Categorization of left out industrial sectors: 'Air Separation Unit' for manufacturing Subject: of 'Oxygen' as primary product and 'Nitrogen & Argon'as by-product.

In pursuance of request received from PBIP and after considering the recommendations made by 'committee constituted by the Board for deciding the categorization of left out industrial sectors', it has been decided to make following addition in the list of industries earlier categorized by the Board under white, green, orange and red category:

Orange	disposals. b) DG set shall be provided with inbuilt acoustic enclosure and adequate stack height. c) Suitable WTP shall be provided for treatment of effluent.
1094	As above with overall liquid waste generation quantities more than 100 KLD (including domestic effluent) and industrial effluent from the chemical processes having high TDS of inorganic nature having presence of criteria pollutants with standard limits from 11 mg/l to 250 mg/l.	Red
