Clarification: Categorization of industry for Compostable Carry Bags. Subject:

In pursuance of request received from Regional Office, Faridkot and after considering the recommendations made by 'sub-committee constituted by the Board for deciding the categorization of left out industrial sectors', it has been decided to issue following clarification with respect to the industries engaged in manufacturing of compostable carry bags:

"As per the definition prescribed under 'The Plastic Waste Management Rules, 2016', carry bag means bag made from plastic material or compostable plastic material. As such, the industry engaged in the manufacturing of compostable carry bag is to be covered under the existing green category having type code 3032 and description Polythene and plastic processed products manufacturing (virgin plastic)."
