Subject: Categorization of left out industrial sectors: 'Seamless Pipe Plants' for manufacturing of Pipes and Tubes

In pursuance of request received from Regional Office, Fatehgarh Sahib and after considering the recommendations made by 'committee constituted by the Board for deciding the categorization of left out industrial sectors', it has been decided to make following addition in the list of industries earlier categorized by the Board under white, green, orange and red category:

Sr. No.	Type code	Industrial Sector – Type	Category
78	3078	Seamless pipe plant for manufacturing of pipe & tubes having processes like reheating, rolling, piercing/manderling, drawing (elongation) etc. (using CNG/PNG/LPG as fuel).	Green
118	2118	Seamless pipe plant for manufacturing of pipe & tubes having processes like reheating, rolling, piercing/manderling, drawing (elongation) etc. (using Oil, Coal or other authorized fuel).	Orange
