M/s Max Speciality Films Ltd., Village Railmajra, Tehsil Balachaur, District Nawanshahr	<p>The case was considered by the SCA-cum-SAC in its 96<sup>th</sup> meeting held on 07.03.2017, wherein the SCA-cum-SAC observed that the case is pending since more than one year for want of conclusive report from PCCF.</p> <p>Representative of PCCF informed that the industry has been requested vide letter No. 6644 dated 23.01.2017 and letter No. 6581 dated 31.01.2017 for submission of NOC from National Highway Authority of India as site falls on NHAI 344A, but the industry has failed to submit the same. He further informed that the application of the industry is incomplete without the said document.</p> <p>After discussions, it was unanimously decided as under:-</p> <ol style="list-style-type: none"> <li>To ask the industry for submission of NOC of NHAI to the Forest Department, immediately.</li> <li>To direct PCCF to expedite the matter personally for sending the conclusive recommendations in the matter, within two weeks, positively.</li> <li>Case be put up in the next meeting of SCA-cum-SAC.</li> </ol>

Road, Goraya, District Jalandhar	<p>The case was considered by the SCA-cum-SAC in its 96<sup>th</sup> meeting held on 07.03.2017, wherein the SCA-cum-SAC observed that:</p> <ul style="list-style-type: none"> <li>CTP, Punjab vide letter no. 4999 CTP (Pb)/SJ-200 dated 13.10.2016 informed that the report from District Town Planner, Jalandhar has been recalled and as per the report, the site of the industry falls in Municipal Council Goraya. The CTP further informed that since the site of the industry falls in Municipal Council, Goraya, as such, in this case Department of Local Bodies is the Competent Authority to grant the permission for change of land use and approval of layout plan. The CTP also informed that the report in this case may be obtained from the Department of Local Bodies. Further, the representative of CTP informed that there is no over taking policy in which the case is covered under the Department of Town &amp; Country Planning.</li> </ul>

- In compliance to the above-mentioned observations of CTP, Punjab, the industry was asked vide letter No. 991 dated 17.11.2016 to get the 'No Objection Certificate' regarding the establishment of the unit from the Municipal Council, Goraya, Tehsil Phillaur, District Jalandhar and submit the same to SCA-cum-SAC for further necessary action.
- In compliance to the above noted decision, the industry vide e-mail dated 07.12.2016 has submitted the copy of NOC issued by the M.C. Goraya vide letter No. 659 dated 06.12.2016.
- DOA vide letter No. 406 dated 15.02.2017 has informed that the Deputy Commissioner, Jalandhar has taken the meeting of District Advisory Committee on 13.01.2017, which was attended by the Members and the owners of the industries. In the meeting, it was decided to advise the industry to apply to the Rural Water Supply Department for water supply connection and submit the NOC from the said department to Deputy Commissioner, Jalandhar for further necessary action. The Deputy Commissioner, Jalandhar has sent the proceedings of the said meeting to the Director Agriculture, Punjab as well as to the industries vide letter dated 02.02.2017.
