M/s Max Speciality Films Ltd., Village Railmajra, Tehsil Balachaur, District Nawanshahr	<p>The case was considered by the SCA-cum-SAC in its 95th meeting held on 26.10.2016, wherein the SCA-cum-SAC observed that:</p> <ul style="list-style-type: none"> The case stands recommended by all the member departments except PCCF. PCCF vide letter No. 9327 dated 07.09.2016 informed that the proposal submitted by the user agency for obtaining the requisite permission from MoEF&CC has been sent by the DFO Nawanshahr to PCCF vide letter No. 3034 dated 08.08.2016 and still there are certain observations in the proposal. The PCCF has written to the DFO Nawanshahr vide letter No. FCA/1980/PBIP/245/2016/8732 dated 22.08.2016 to get the incompletions made clear from the industry. The PCCF further informed that the case will be sent to the Govt. of Punjab for according requisite permission on receipt of complete reply to the observations. <p>After discussions, the representative of PCCF was directed to expedite the matter personally and to get the requisite report from DFO Nawanshahr and to send the conclusive recommendations in the matter within two weeks, positively and the case be put up in the next meeting of SCA-cum-SAC.</p>

day-to-day basis and will send its conclusive recommendations, immediately. It was further decided to defer the case and be put up in the next meeting of SCA-cum-SAC alongwith the conclusive recommendations of the Agriculture Department.

2. M/s Shree Mahavir Agricultural Industries, Village Kutbewal, G.T. Road, Goraya, District Jalandhar
- The case was considered by the SCA-cum-SAC in its 95th meeting held on 26.10.2016, wherein the SCA-cum-SAC observed that:
- The case stands recommended by all the member departments except CTP & DOA and the Punjab Pollution Control Board vide letter no. 9591 dated 18.10.2016 has recommended that site clearance be granted to the industry subject to report/recommendation of DTP & DOA.
 - DOA vide Endst. No. 1814-15 dated 21.10.2016 informed that the Deputy Commissioner, Jalandhar has been requested vide letter No. 1813/JDA (HG) dated 22.08.2016 to convene a meeting of District Advisory Committee for consideration of the case of the industry. DOA vide Endst. No. 2237-39 dated 21.10.2016 again informed that the Deputy Commissioner, Jalandhar has again been requested vide letter No. 2236/JDA (HG) dated 21.10.2016 to convene a meeting of District Advisory Committee for consideration of the case of the industry, but no meeting has been convened as yet.
 - CTP, Punjab vide letter no. 4999 CTP (Pb)/SJ-200 dated 13.10.2016 informed that the report from District Town Planner, Jalandhar has been recalled and as per the report, the site of the industry falls in Municipal Council Goraya. The CTP further informed that since the site of the industry falls in Municipal Council, Goraya, as such, in this case Department of Local Bodies is the Competent Authority to grant the permission for change of land use and approval of layout plan. The CTP also informed that the report in this case may be obtained from the Department of Local Bodies. Further, the representative of CTP informed that there is no over taking policy in which the case is covered under the Department of Town & Country Planning.

After discussions, the following decisions were taken:

- (i) The industry be asked to get the 'No Objection Certificate' regarding the establishment of the unit from the Municipal Council, Goraya, Tehsil Phillaur, District Jalandhar and submit the same to SCA-cum-SAC for further necessary action.
- (ii) Representative of DOA was directed to take up the matter with Deputy Commissioner, Jalandhar for convening a meeting of District Advisory Committee, Jalandhar, immediately and DOA

will send the final conclusive recommendations in the matter, within 15 days, positively.

- (iv) Case be deferred till the industry submits the 'No Objection Certificate' from the Municipal Council, Goraya, Tehsil Phillaur, District Jalandhar.
3.
