Registration & renewal of recycler, reprocessor or reuse of hazardous waste under Rule 8 of the Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2008.

Ministry of Environment & Forests, Govt of India vide notification no. S.O. 1996(E) dated 13.08.2010 (under the Environment (Protection) Act 1986) have delegated powers to the concerned State Pollution Control Boards for Registration & renewal of registration of units for recycling/ reprocessing or reuse of hazardous waste listed in the Schedule-IV of the Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2008. For this purpose, a team consisting of the following members is hereby constituted:

- i) S.E.E. /E.E., HWM Cell, Head Office, Patiala
- ii) S.E.E. / E.E., Concerned Zonal Office
- iii) E.E. / A.E.E., Concerned Regional Office.

### Terms & conditions:

- 1. There should be atleast two officers from different offices for each visit for verifying the facts as mentioned above.
- 2. The inspection team will visit the industry and submit its report within 15 days to the Registration Committee constituted by the Board for the subject cited purpose.
