Subject: Harmonization of Classification of Industrial Sectors into Red, Orange, Green and White Categories regarding Spice Grinding Units.

The categorization of industries earlier made by the Board, in compliance to the directions issued by the CPCB u/s 18 (1) b of the Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 vide order no. SEE(HQ-2)/F-10(Vol.II)/458 dated 29.09.2016, is partially modified to the extent that the 'Dry Grinding of Spices' placed inadvertently at Sr. No. 4072 in the list of white category of industries, is hereby 'omitted.' From now onwards, this 'Spice Grinding' activity shall only be covered under green category as mentioned at Sr. No. 3044 and 3045 in the respective list.

These orders shall be operative with immediate effect.
