Subject:

Re-distribution of the area allotted to M/s Rainbow Environments Pvt. Ltd., Mohali for treatment and disposal of Bio-medical Waste amongst the other Common Biomedical Waste Treatment Facilities (CBWTFs) operating in the State of Punjab.

M/s Rainbow Environments Pvt. Ltd., Village Balyali, SAS Nagar was given a personal hearing on 08-06-2023 regarding violation of the provisions of various provisions of the Water (Prevention and Control of Pollution) Act, 1974, Air (Prevention and Control of Pollution) Act, 1981 & provisions of Biomedical Waste Management Rules, 2016 and Hazardous Waste Management Rules, 2016, wherein it was decided that the operator shall stop the operation of the CBWTF for collection, transportation, treatment and disposal of biomedical waste after 10-07-2023 and shall not restart the operation without making compliance of the incompletion pointed out by the Board and without having valid consents to operate under the Water (Prevention and Control of Pollution) Act, 1974 & Air (Prevention and Control of Pollution) Act, 1981, authorization under the Hazardous and Other Waste (Management and Transboundary Movement) Rules, 2016 and Bio-Medical Waste Management Rules, 2016.

- Considering the practical difficulties of collection and transportation of Biomedical Waste, the Competent Authority of the Board has amended its decision vide letter no. 15809 dated 10-07-2023 to the effect that M/s Rainbow Environments Pvt. Ltd., Village Balyali, Mohali shall not restart the operation of the facility for treatment & disposal of biomedical waste after 10-07-2023 and shall continue with collection and transportation of biomedical waste from the health care facilities under area of its jurisdiction and transportation of the same to the other CBWTFs where the order for re-distribution for treatment and disposal for biomedical waste is being issued separately and shall not restart the operation without making compliance of the incompletion pointed out by the Board and without having valid consents to operate under the Water (Prevention and Control of Pollution) Act, 1974 & Air (Prevention and Control of Pollution) Act, 1981, authorization under the Hazardous and Other Waste (Management and Transboundary Movement) Rules, 2016 and Bio-Medical Waste Management Rules, 2016.
- In compliance with the aforesaid letter, the area allotted to M/s Rainbow Environments Pvt. Ltd., Mohali for treatment and disposal of Bio-medical Waste amongst the other 04 Common Biomedical Waste Treatment Facilities (CBWTFs) operating in the State of Punjab is re-distributed as under:

- i) M/s Rainbow Environments Pvt. Ltd., Mohali shall collect the entire bio-medical waste (yellow, red, white and blue category) including the COVID waste on a daily basis from its allocated area and transport it to the other CBWTFs as allocated in the aforesaid table on payment basis mutually agreed upon.
- ii) M/s Rainbow Environments Pvt. Ltd., Mohali shall ensure compliance of the Bio-Medical Waste Management Rules, 2016 during the collection and transport of bio-medical waste.
- iii) M/s Rainbow Environments Pvt. Ltd., Mohali shall submit a report to the Regional Office, Mohali on a daily basis regarding the collection and transportation of bio-medical waste (category-wise) to the respective facilities as mentioned above.
- iv) This order shall be read in conjunction with the earlier order no. 191 dated 05-06-2023 and 217 dated 19-06-2023 issued regarding the re-distribution of area for collection, treatment, transportation and disposal operating in the State of Punjab. Further, this order should remain operative till directions issued vide letter no. 4300-4304 dated 21-06-2023 and 4295-4299 dated 21-06-2023 to M/s Rainbow Environments Pvt. Ltd. are revoked.
