### **Office Order**

The matter regarding extension in the validity of 'consent to establish' (NOC) being granted to the entrepreneurs was considered in  $168^{th}$  Board Meeting vide Item No. 168.07 held on 15/7/2015 and the Board decided as under:

"In case, the project is not covered under the provisions of EIA notification dated 14/9/2006, then NOC be granted to the industry for one year or a period as per its implementation period after getting deposited full NOC fee for 1<sup>st</sup> year and half the fee of NOC for subsequent years, but the validity period of NOC shall not be more than 5 years. In case, the project / plant is not implemented within 5 years, then the validity of 'consent to establish' (NOC) already granted to the industry will not be extended and the industry shall obtain afresh NOC for the same for which new guidelines prevailing at that time shall apply."

These orders will come into force with immediate effect.
