#### OFFICE ORDER

Amended Guidelines for the utilization of Grant-In-Aid received from the Government of India and the Government of Punjab for setting up of CETPs.

In supersession to the office order issued by the Punjab Pollution Control Board vide no. SEE(ZO-2/LDH/CETP-27 dated 12.07.2017, the guidelines for the utilization of Grant-in-Aid from Central and State Government for the installation of CETPs has been amended as under:

## 1. Role of Special Purpose Vehicle (SPV)

- 1.1 Before the release of Grant-in-Aid, the SPV shall submit a Bank Guarantee of matching amount to be released by the Central & State Grant-in-Aid.
- 1.2 SPV will ensure completion of work as per the time targets given by the Central & State Govt.
- 1.3 SPV will ensure the meticulous compliance of all the terms & conditions of the sanction/release order of the Central/State Govt. while sanctioning the release of Grant-in-Aid.

### 2. Constitution of Managing Committee

2.1 The SPV shall constitute a Managing Committee by nominating the following members:

### 3 Functions of Managing Committee

- (i) Oversee physical and financial progress made by the executing agency regarding the installation of CETP.
- (ii) Suggest suitable/ appropriate steps for proper execution and completion of the project.
- (iii) Discuss any issue relating to the installation & commissioning of the CETP.
- (iv) Verify and approve the bills submitted to the SPV by Executing Agency, in terms of quality and quantity of the work done.
- (v) Submit the documents to Member Secretary, Punjab Pollution Control Board for release of Central and State Grant in Aid.
- (vi) It will not allow any funding of the expenditure made by the Executing Agency prior to the sanction of the project by the Central or State Government.
- (vii) It will upload the necessary details in the PFMS system and will also submit its confirmation to Punjab Pollution Control Board.
- (viii) It will pass a resolution that the work by the executing agency has been completed as per the terms & conditions as mentioned in the sanction letter issued by the Central Govt.

The above guidelines shall be followed for making future payments so as to expedite the work.
