

OFFICE ORDER

In matters pertaining to the violations or otherwise, the industrial units/other establishments are being given opportunity of personal hearing before taking any penal action against them. In number of cases, the project proponents failed to appear for hearing before the concerned authority on scheduled date & time. Most frequent reason being cited for non-appearance is non-receipt of notice or late delivery of notice(s) to them. Needless to say that number of hearings are being given in compliance of the decisions of Hon'ble National Green Tribunal (NGT) or in compliance of the decisions of NGT Monitoring Committee. Such delays will not only defeat the very purpose for which the notice / hearing was given but also makes the position of the Board awkward before the above authorities.

It has now been decided that all such notices/letters for hearing being issued by the Board shall not only be send through registered post but also through email and whatsapp message to the project proponents / industrial units so as to ensure their delivery well in time.

This order will be applicable with immediate effect.


