OFFICE ORDER

Subject: Nodal Officers for coordination with Urban Local Body officials/Cement Companies for smooth transport of collected plastic waste from villages to cities for processing in cement plants.

It is intimated that Ministry of Housing and Urban Affairs (MOHUA) vide its letter D.O. No. Q- 15014/10/2019-CPHEEO dated September 5th, 2019 has informed that in response to the call given by Hon'ble PM to make India free from single use plastic, "Swachhata hi Seva" campaign will commence on September 11th, 2019, and will continue till October 27th, 2019 in three phases, with the theme of "Plastic Waste Shramdaan" as below: -

Phase-1	11 th September-1 st October, 2019	Preparation and Awareness generation
Phase-2	2 nd October, 2019	'Shramdaan' as mass movement
Phase-3	3 rd -27 th October, 2019	Recycle/Disposal of collected plastic waste, leading to a plastic- free Diwali

Further, all the States have been directed to organize large scale citizen engagement activities for awareness generation and community mobilization through Sharamdaan, Clean and Green Drives, Swachhata Pledges, Swachhata Rallies, etc, aimed at mass scale plastic waste collection and disposal, during this period. Cement Manufacturing Association (CMA) have been directed by Central Govt. for transportation of collected plastic waste to their nearest cement plants (within 200 kms range of the cements plants) for use as alternative fuel in their furnaces.

CPCB vide its letter no. B-170117/PWM(Corres)/2019 dated 18.09.2019 has requested Board to participate actively in the Campaign and nominate District Level Nodal Officers which may be contacted by ULBs/Cement Companies for smooth transport of collected plastic waste from villages to cities for processing in cement plants.
