OFFICE ORDER

The Punjab Pollution Control Board has provided an online facility for industries/other project proponents to submit consent/authorization applications through Online Consent Management and Monitoring System (OCMMS). As per instructions issued vide office order no. 433 dated 06.11.2013, online payments are only mandatory for Large/Medium scale industrial units, whereas the facility is optional for small scale industrial units.

The Government of Punjab, Department of Science, Technology & Environment vide memo no. 8/8/2017/STE-5/1598468/1 dated 16.10.2019 has issued directions u/s 18(1)(b) of the Water (Prevention & Control of Pollution) Act, 1974 as well as the Air (Prevention & Control of Pollution) Act, 1981 for revamping the Consent Management system and particularly making all the payments online.

As such, in compliance to the above directions of the Government, it has been decided to make it mandatory for all category of industries to pay applicable fee for processing of consent/authorization applications through online mode only irrespective of the scale of industries.


These orders will come into force with immediate effect.


