
Subject: Standards for the discharge of treated domestic effluent at the outlet of STPs

The Board in its 186th meeting held on 31.03.2021 has considered the recommendations of the Govt. for the deletion of parameters namely SAR (Sodium Adsorption Ratio), EC (Electrical Conductivity) and RSC (Residual Sodium Carbonate) from the treated sewage quality requirement (in the DNIT for rejuvenation of Budha Nallah at Ludhiana under the AMRUT scheme) made during a meeting held on 25.09.2020.

The Board, after detailed deliberations, has decided to allow the above exemption subjected to review of the improvement expected in the quality of said parameters upon commissioning of STPs & CETPs for dyeing industries at Ludhiana and dilution after release of water in Budha Nallah.

The Department of Local Govt. shall be bound to comply with the effluent standards being revised by the Ministry of Environment, Forest & Climate Change in compliance of the directions issued by the National Green Tribunal in OA No. 1069/2018 as & when finalized.

These orders will come into force with immediate effect.
