## OFFICE ORDER

Regarding online module in OCMMS for filing Annual Return under the Construction and Demolition Waste Management Rules, 2016.

In continuation to earlier efforts for providing ease of doing business to the industries/entrepreneurs and to further reduce the compliance burden on the industries / entrepreneurs, the Board has developed an online module in Online Consent Management and Monitoring System (OCMMS) in order to allow the industries/entrepreneurs to file the Annual Returns online.

The Annual Return Module can be accessed by the industry/ entrepreneurs by following the below steps:

- 1. Goto the Board's Official Website www.ppcb.punjab.gov.in
- Click on Online Consent Management and Monitoring System (OCMMS) under the E-Governance Projects. The browser will redirect to the OCMMS portal at <a href="https://pbocmms.nic.in">https://pbocmms.nic.in</a>.
- 3. The provision to file the Annual Return under C&D Rules would be available in the Industry Account under *Waste Management ----> Annual Return -----> File under Construction and Demolition Rules.*

The Returns filed online would then be available in the account of the concerned Environmental Engineer (Regional Office) for necessary action.

In view of the recent development in OCMMS, all the Regional Offices of the Board are hereby directed as follows:

- 1. The said provision should be circulated and brought into the notice of all concerned stakeholders for filing the Annual Return in Online Mode only.
- 2. No hard copy of return should be entertained.
- 3. The Helpdesk staff be also directed accordingly to guide the industries/ entrepreneurs for using the online mode for filing the Annual Return in OCMMS.

This order shall come into force with immediate effect.
