OFFICE ORDER

The Central Pollution Control Board (CPCB) had issued directions u/s 18(i) (b) of the Water (Prevention & Control of Pollution) Act, 1974 and the Air (Prevention & Control of Pollution) Act, 1981 vide letter no. B-29012/ESS/2015-16/8584 dated 07.03.2016 with regard to the harmonization of classification of industrial sectors under Red, Orange, Green & White categories.

And whereas, in view of the aforesaid directions of the CPCB, the Punjab Pollution Control Board vide office order no. SEE(HQ-02/F-10/Vol. II/458 dated 29.09.2016 had issued categorization of industries thereby, exempting 137 type of industries from the consent management of the Board subject to following conditions:

- i) That the industry is established/being established in the demarcated Industrial Estates/Zones classified by the State Authorities viz PSIEC, Department of Industries, PUDA, CTP under draft Master Plan or in mixed category area or predominantly Industrial areas within Municipal limit of a Town/City after classification of the area by CTP/STP/DTP.
- ii) That the investment of the industry is not more than Rs. 1 Crore on plant and machinery.
- iii) That there will not be any discharge of trade effluent from the industry into stream or well or sewer or onto land and/or that industry will not discharge any air pollution including noise into the atmosphere.
- iv) That the industry will not discharge any toxic/hazardous wastes and will not handle any toxic/hazardous chemical.

And whereas, as per the condition no. ii) above, the privilege to avail the exemption from obtaining consent under the White Category is extended only to those units, which have investment of plant & machinery upto Rs. 1.0 crore.

And whereas, PPCB has received representations from various quarters for the exemption of the above condition. One such representation made by M/s Abohar Power Generation Private Limited, Noida for exempting their Hydel Projects (upto 25 MW) is received from CPCB with directions to examine the same as per directions issued by them for categorization of industries. Punjab Energy Development Agency (PEDA) has also emphasized for exemption of the Mini Hydel Projects to prompt the industrial sectors to adopt cleaner technologies.

And whereas, the matter was placed before the Board in its 183rd meeting held on 12.12.2019, wherein it was decided to follow the guidelines / rules stipulated by CPCB in this respect.

As such, it has been decided that the condition no. (ii) stipulated in the office order no. SEE(HQ-02/F-10/Vol. II/458 dated 29.09.2016 stands deleted which implies that the privilege to avail the exemption from obtaining consent under the 'white category' is extended to all the 137 type of industrial units/other establishments notified by the Board in its notification dated 29.09.2016 including the Mini Hydel Projects (upto 25 MW) irrespective of the investment on the plant & machinery.

These orders will come into force with immediate effect.
