Subject:

Standardization of workflow for processing of authorization/ registration applications and e-notings received through OCMMS/ e-office under various waste management Rules.

In continuation to Board's memorandum bearing no. SEE(HQ-2)/2021/OM No. 517 dated 01-10-2021, it has further been noticed that some of the officers are deciding the waste management applications received through OCMMS/ e-office at their own level without following the Competency orders of the Board as well as the compliance of provisions of Waste Management Rules from time to time.

As such, it has been decided to circulate a common procedure/ workflow which will be followed in future by all the officers of the Board for processing of authorization/ registration applications and e-notings received through OCMMS/ e-office under various Waste Management Rules (Bio-medical Waste Management Rules, 2016, Plastic Waste Management Rules, 2016, Hazardous Waste Management Rules, 2016, E-waste Management Rules, 2016, Solid Waste Management Rules, 2016), action under section 5 of Environment (Protection) Act, 1986 and imposition of Environmental Compensation (EC) under above Rules as per annexure attached.

These orders shall come into force with immediate effect.







For authorization applied by bulk waste generators, dismantlers, recyclers and common facilities of E- waste and related e-notings/e-office:




