Subject:

Regarding issued being faced in Online Consent Management and Monitoring System (OCMMS) and Business First Portal (BFP).

It has been observed during a recent meeting with the Policy Implementation Unit (PIU), Department of Industries & Commerce that issues are being faced in the applications being received in OCMMS through the BFP, whereby the industries were having different details in the BFP CAF Form and OCMMS profile/applications. It has also been observed that multiple applications of different industries were being filled through single BFP Portal account, through repetitive updation of the profiles such as industry name, address, scale etc. on the BFP and OCMMS. Due to this, multiple issues are being faced in OCMMS including unattended applications, missing data, mismatched details etc.

In order to curb such practices, the provision for updation of profile has been disabled from the industries' account in OCMMS. Further it has been decided that in case there is some updation required, the following procedure is to be adopted:

- 1. In case there is some updation required in the industry's profile in OCMMS, the industry should submit a request to the concerned Regional Office.
- 2. The concerned Regional Office, after due verification of the details must send a request to the Computer Section through email at <a href="mailto:computer.section.ppcb@gmail.com">computer.section.ppcb@gmail.com</a> specifically mentioning what values are required to be updated.
- 3. Thereafter, the Computer Section would get the details updated in the industry profile.

These orders shall come into force with immediate effect.
