Subject: Guidelines for CNG Retail Outlets/Dispensing Stations being established in the State of Punjab.

Reference: CPCB letter no. B-13011/1/2020-21/AQM-CNG Guidelines/2306 dated 18.07.2022

It is intimated that vide this office letter No. 15166 dated 06.07.2021, it was informed to all the Deputy Commissioners and others stakeholder departments about the siting criteria for CNG Retail Outlets/Dispensing Stations. Later on, CPCB vide letter no. 13011/1/2020-21/AQM-SPCBs/PCCs/5765 dated 01.09.2021 has clarified that the guidelines for setting up of new petrol pumps will not apply to CNG retail outlets and are only applicable for Lube Oil, Petrol and Diesel fuel selling outlets.

In a latest reference received from CPCB vide letter no. B-13011/1/2020-21/AQM-CNG Guidelines/2306 dated 18.07.2022, it has been further elaborated that environmental guidelines/siting criteria may not be required for CNG retail outlets/dispensing stations. However, all existing guidelines would be applicable to CNG retail outlets/dispensing stations. Further, the measures prescribed with respect to fire, safety and leakages by various authorities should be strictly adhered to.



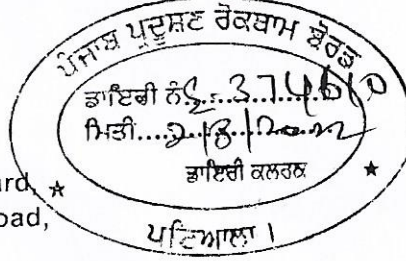
