OFFICE MEMORANDUM

Subject: Site suitability reports by the Revenue and other authorities for establishment of industrial and other projects.

The Board in its 90th meeting held on 30.09.2022 has decided to partially modify clause G (Siting Criteria) of its comprehensive policy for Consent Management/ Authorization issued vide letter no. EE(Mega)/2013/19650-761 dated 30.04.2013 as illustrated below:

G. Siting Criteria (page 12 of 25)

1. Page 13: Words "*Deputy Commissioner/Additional Deputy Commissioner or Sub-Divisional Magistrate*" shall be substituted by the word "*Circle Revenue Officer (CRO)/ Tehsildar*".
2. In case of confirmation of distance of any feature from the project land related to or falling in the territory of notified/draft master plans or regarding the confirmation of land use/zoning/permisibility of site/LPA/urbanized limits etc., such reports are to be provided by the District Town Planner (DTP).
3. CLU/NOCs wherever applicable, issued by the concerned authorities (DTP/STP/CTP) or PUDA authorities like GMADA/GLADA/other development authorities shall also be accepted, in case it provides the confirmation of zone/permisibility of site.
4. In case of the projects falling within the MC Limits, such certification/CLU/NOC issued by the concerned authority in Local Body viz. Municipal Commissioners/Executive Officers shall be accepted.
5. In case of notified industrial areas/estates/focal points, certification/allotment letters issued by Department of industries/PSIEC/PIDB/PBIP etc. shall be accepted as the confirmation of zone/permisibility of area.

This order shall come into force with immediate effect.
