The Central Government has delegated the powers vested in it under section 5 of the Environment (Protection) Act, 1986 to the State Government of Punjab vide notification no. S.O.(389) dated 14.04.1988, where under the State Government is empowered to issue any directions in writing to any person, officer or authority and such officer or authority shall be bound to comply with such directions.

- 2. Under the provisions of Rule-6, the Recyclers / Re-processors or Reuse of hazardous waste listed in Schedule IV of the Hazardous and other waste (Management and Transboundary) Rules, 2016, are required to obtain registration from the Punjab Pollution Control Board.
- 3. Earlier, the Punjab Pollution Control Board vide office order no. HWM/EE/Registration/2011/no.79 dt. 16.03.2011 had approved the registration fee of Rs. 2500/- with each application filed under rule-6 of the Hazardous and other waste (Management and Transboundary) Rules, 2016 on the basis of "polluter pay" & "precautionary principle".
- 4. Punjab Pollution Control Board in its 182<sup>nd</sup> meeting held on 27.06.2019 considered and approved the matter regarding revision of application processing fee for the registration with the Board under Rule 6 of the Hazardous and Other Wastes (Management & Transboundary Movement) Rules, 2016.
- Now, the following processing fee shall be paid by the recycler/re-processor for reuse of hazardous waste listed in Schedule-IV of Hazardous and Other Wastes (Management & Transboundary Movement) Rules, 2016 for issuance of Registration Certificate/Passbook:

Sr. No.	Scale of Industry	Registration fee to be charged (in Rs.)
1.	Small	10000
2.	Medium	15000
3.	Large	25000

The notification will come into force from the date of issuance.
