Subject: Clarification regarding processing fee for Consent to Establish/ Operate issued vide office order no. 524 dated 29.10.2018.

This has reference to the representation received from EE, RO, Bathinda through Chief Office, Bathinda regarding addition of more slabs of fixed capital investment above 5000 crores in the office order no. 524 dated 29.10.2024 to increase revenue from the industries having fixed capital investment of about 2 to 4 times more than 5000 crores.

The matter has been deliberated time and again in the in-house meetings of officers of the Board. Lastly, the matter was considered in the meeting dated 04.09.2024 held under the chairmanship of Hon'ble Chairman of the Board. It is observed that CPCB is already in the process of framing guidelines for uniform consent fee across the State Pollution Control Boards.

It has been decided that the industries in the bracket amount of 5000 crores and above shall be given consent on year to year basis till the matter regarding their consent fee is decided at CPCB/PPCB level. In case, the industries still insist for long term consent, an undertaking be obtained from such industries to deposit consent fee as per revised rates from the date of notification by the CPCB/PPCB and the industries have to pay the arrears accordingly.
