For allowing 2% of contract demand or 100 KW (whichever is lower) for office work, in case directions are issued for disconnection of electricity

Considering the representation of the Industrial Associations, it has been decided that while issuing directions for disconnection of electric connection of the defaulting units in case of violation of the provisions of Environmental Laws, the Board will allow 2% of the contract demand or 100 KW (whichever is less) of electric power to such units specifically for office use only.

This order shall come into force with immediate effect.
