Subject: Clarification: Categorization of industry in case of multiple activities or products falling under different sectors (Red, Orange, Green or White)

In pursuance of request received from Zonal Office-2, Patiala and after considering the recommendations made by 'sub-committee constituted by the Board for deciding the categorization of left out industrial sectors', it has been decided to issue following clarification:

"In case of multiple activities or products involved in the manufacturing chain of industry, but falling under different categories (Red, Orange, Green or White), the industry is to be categorized under stringent one (more polluting)".

Illustration: In case, two different industrial activities say electroplating (Red category) and injection moulding (Green category) are operating within same premises of an industrial unit, then the industry is to be categorized as red category.

This clarification may be appended to the Board's office order no. SEE(HQ-2)/2020/585 dated 23.10.2020, letter no. 2457-59 dated 03.02.2021, 5785-87 dated 15.03.2021, 18555-77 dated 17.08.2021, 23407-09 dated 26.10.2021 and office memorandum no. 65 dated 11.03.2022.
