BOARD'S ORDER

In partial modification of letter No. Admn./SA-2/E No. 96/308 Dated 27.12.1996, the Senior Environmental Engineers of the Board are delegated powers as under:

To grant "Consent to Operate" to the small scale industries in non-designated areas, in case the industry has been issued NOC by the Chairman or Member-Secretary of the Board.

In case the industry has been established prior to 16.8.2000 without obtaining 'Consent to establish' of the Board and applies for "Consent to Operate" of the Board, then Senior Environmental Engineers may consider grant of "Consent to Operate" as per the following decision of the Board taken in its 107<sup>th</sup> meeting held on 7.7.2000.

"The Board may grant "Consent to Operate" to old reg category of industries operating in approved residential areas or mixed areas but required to be shifted, if they have installed adequate Effluent Treatment Plant and Air Pollution Control Devices. Initial "Consent to Operate" shall be for a period of one year with the condition that it will shift to the designated industrial area within stipulated period".

This delegation will be in addition to the existing powers of the Senior Environmental Engineer.


