Subject: Policy to be Adopted for Installation of sewage treatment plant for colonies proposed to establish/being established

It has been decided to adopt following policy for installation of sewage treatment plant for colonies proposed to establish/being established: -

- If the colony is proposed to establish/being established within the municipal limits of a City/Town of the State and proposes to discharge its entire sewage into sewer and the local body of that city/town has no proposal for installation of sewage treatment plant; then the promoter of the colony shall submit feasibility report and install adequate and appropriate individual sewage treatment plant.
- If the colony is proposed to establish/being established within the municipal limits of a City/Town of the State and proposes to discharge its entire sewage into sewer

and the local body of that city/town has a proposal to install sewage treatment plant or that city/town is covered under the *Satluj Action Plan /West Bein Project/PUDA STP Project*, then the promoter of the colony shall not be insisted upon by the Board for installation of individual sewage treatment plant.

➤ If the colony is proposed outside the municipal limits of a city/town of the State and the promoter gives undertaking to discharge its entire sewage into sewer having sufficient capacity by laying his own sewer line upto the sewerage of that city/town and the local body of that city/town has no proposal for installation of sewage treatment plant, then the promoter of the colony should install adequate and appropriate individual sewage treatment plant.

➤ If the colony is proposed outside the municipal limits of a city/town of the State and the promoter gives undertaking to discharge its entire sewage into sewer having sufficient capacity by laying his own sewer line upto the sewerage of that city/town and the local body of that city/town has a proposal to install sewage treatment plant or that city/town is covered under the *Satluj Action Plan /West Bein Project/PUDA STP Project*, then the promoter of the colony should not be insisted upon by the Board for installation of individual sewage treatment plant.

➤ If the colony is proposed to establish/being established outside the municipal limits of a city/town of the State and the promoter has no facility for discharge of sewage into sewer, then, the promoter should install individual adequate sewage treatment plant and the promoter should also submit the distribution scheme of sewage for discharge of sewage on to land for irrigation/forestry.
