OFFICE ORDER

The earlier orders issued vide No. Admn/SA-1/F.No.}2007/754 dated 23/8/2007 regarding consent to establish / consent to operate to industrial units related to Information Technology and Communication Network such as Telecommunication Towers have been reviewed.

Now, it has been decided to deal such cases as under:

- (a) Every company will file an application in the concerned Regional Office of the Board on green category form for individual Tele Communication Tower instead of single application for group of towers of the same company.
- (b) The application so received shall be accompanied by NOC from Local authorities/DTP as the case may be, regarding suitability of site alongwith other documents as prescribed by the Board. The Regional Office shall decide the application after proper field verification and taking care of following points.
 - i) The DG set installed with the Telecommunication Tower must conform to the Noise Level Standards as prescribed for DG sets under the EPA, 1986.
 - ii) The foundation of the DG set should be properly designed to control vibrations from the DG set.
