Subject: Proceedings of the public hearing conducted on 02.06.2022 in connection with application filed by M/s Belco Special Steels Private Ltd., for obtaining environmental clearance under EIA Notification dated 14.09.2006 for establishment of a new steel manufacturing unit in the revenue estate of Vill. Turan, Opposite Simran Steel Industries, Amlah Road, Mandi Gobindgarh, District Fatehgarh Sahib.

It is intimated that the subject cited industry had applied for obtaining Environmental Clearance as required under the EIA Notification dated 14.09.2006 for establishment of a new industrial unit in an area of 10.33 acres in the revenue estate of Vill. Turan, Opposite Simran Steel Industries, Amlah Road, Mandi Gobindgarh, District Fatehgarh Sahib for the manufacturing of Alloys steel bars @ 1,80,000 TPA by installing two no. induction furnaces of 18 TPH capacity each and one Rolling Mill. The project is covered under Ministry of Environment, Forest and Climate Change, Govt. of India notification no. S.O. 1533 (E) dated 14.09.2006 and thus is required to obtain Environmental Clearance from the SEIAA, Punjab. The Terms of Reference for preparing draft study report for the said project were prescribed by State Level Environment Impact Assessment Authority (SEIAA), Punjab vide no. 4932 dated 14.12.2021. The industry had submitted draft EIA study report to the Board and had requested for conduct of public hearing of this project.

In compliance to the provisions of the EIA notification dated 14.9.2006 & Office Memorandum dated 14.09.2020, the Board has fixed the date of public hearing as 02.06.2022. Public notices were published in two daily newspapers namely 'Indian Express' & 'Punjabi Tribune' on 30.04.2022 for getting responses from public and intimating date, time & venue of the public hearing. The copies of the said notices are enclosed herewith as **Annexure-I**. The public announcements and banners were displayed in the vicinity / nearby villages to give the wide publicity of the public hearing by the Board. Thereafter, public hearing for the said project was conducted on 02.06.2022. The public
