| 1.             | M/s Sukhjit Mega Food Park & Infra Ltd., Village Rehana Jattan, Tehsil Phagwara, District Kapurthala | <p>The case was considered by the SCA-cum-SAC in its 95<sup>th</sup> meeting held on 26.10.2016, wherein the SCA-cum-SAC observed that the representative of the DOA stated in the meeting that meeting of District Advisory Committee, Kapurthala has been fixed today i.e. on 26.10.2016 for deciding the said case.</p> <p>After discussions, it was decided to the Department of Agriculture will be pursue the case on day-to-day basis and will send its conclusive recommendations, immediately. It was further decided to defer the case and be put up in the next meeting of SCA-cum-SAC alongwith the conclusive recommendations of the Agriculture Department. DOA also recommended the case for grant of site clearance vide No. No. 2281/JDA (HG) dated 07.11.2016. The case stands recommended by all the Member Departments.</p> <p>The case of the promoter company alongwith above representation dated 02.01.2017 of the promoter company was processed on the record file for considering the case to recommend the same to Director of Factories, Punjab for issuance of requisite site clearance (as all the Member Departments including Department of Agriculture have recommended for grant of site clearance to the promoter company). The Chairperson, SCA-cum-SAC accorded approval to</p> |

recommend the case for grant of site clearance by imposing conditions as conveyed by the member departments. The Chairperson has also approved for placing the case before the SCA-cum-SAC in its next meeting for according post-facto approval of the same. Road, Goraya, District Jalandhar | <p>The case was considered by the SCA-cum-SAC in its 95<sup>th</sup> meeting held on 26.10.2016, wherein the SCA-cum-SAC observed that:</p> <ul style="list-style-type: none"> <li>• The case stands recommended by all the member departments except CTP &amp; DOA and the Punjab Pollution Control Board vide letter no. 9591 dated 18.10.2016 has recommended that site clearance be granted to the industry subject to report/recommendation of DTP &amp; DOA.</li> <li>• DOA vide Endst. No. 1814-15 dated 21.10.2016 informed that the Deputy Commissioner, Jalandhar has been requested vide letter No. 1813/JDA (HG) dated 22.08.2016 to convene a meeting of District Advisory Committee for consideration of the case of the industry. DOA vide Endst. No. 2237-39 dated 21.10.2016 again informed that the Deputy Commissioner, Jalandhar has again been requested vide letter No. 2236/JDA (HG) dated 21.10.2016 to convene a meeting of District Advisory Committee for consideration of the case of the industry, but no meeting has been convened as yet.</li> <li>• CTP, Punjab vide letter no. 4999 CTP (Pb)/SJ-200 dated 13.10.2016 informed that the report from District Town Planner, Jalandhar has been recalled and as per the report, the site of the industry falls in Municipal Council Goraya. - (i) The industry be asked to get the 'No Objection Certificate' regarding the establishment of the unit from the Municipal Council, Goraya, Tehsil Phillaur, District Jalandhar and submit the same to SCA-cum-SAC for further necessary action.
- (ii) Representative of DOA was directed to take up the matter with Deputy Commissioner, Jalandhar for convening a meeting of District Advisory Committee, Jalandhar, immediately and DOA will send the final conclusive recommendations

in the matter, within 15 days, positively.

- (iv) Case be deferred till the industry submits the 'No Objection Certificate' from the Municipal Council, Goraya, Tehsil Phillaur, District Jalandhar.
