M/s Max Speciality Films Ltd., Village Railmajra, Tehsil Balachaur, District Nawanshahr	The case was considered by the SCA-cum-SAC in its 93 rd meeting held on 06.06.2016, wherein the SCA-cum-SAC observed that: ➤ PCCF vide letter no. 5080 dated 26.05.2016 has informed that the spot inspection of the area where proposed project is to be established was made with the Manager of the company. 38070 sqm forest area is involved where the new unit is to be established. As per plans, the user agency has to construct the buildings on 11524 sqm and 19953 sqm area has been reserved for green belt. Besides above, the industry has already constructed the buildings & roads on 6593 sqm area. The above noted total forest area 38070

sqm is falls under section 4 of PLPA, 1900 and the coordinates of the same are as under:

The PCCF further informed that the besides above, the industry is using approach to the industrial premises from Ropar-Balachaur Road for which 342.35 sqm protected forest area is being affected. The GPS coordinates of the same are as under:

The representative of PCCF stated that the industry is not responding to the observations of the Department.

- Punjab Pollution Control Board vide letter no. 4640 dated 31.05.2016 has informed that the industry has neither submitted certificate from Revenue Authorities regarding distances from Lal Lakir/Phirni of the nearest Village to the boundary of the premises of the industry nor submitted classification of the area as per notified Master Plan Ropar. Punjab Pollution Control Board further informed that the case of the industry may be considered after considering the report of area classification from the Competent Authority and submission of certificate from the Revenue Department regarding distance of Lal Lakir/Phirni of the nearest village to the boundary of the premises of the industry.
- Fresh comments from DOA are awaited. However, representative of DOA informed that the some documents are being collected from the industry and he assured that the final report of the Department will be sent within a week, positively.

After detailed discussions, following decisions were taken:

- (i) To convey the above mentioned observations of PPCB & PCCF to the industry for compliance and to ask it to submit compliance report of the observations directly to the concerned departments under intimation to SCA-cum-SAC.
- (ii) The representative of DOA was directed to expedite the matter and to send the final recommendations in the matter within a week, positively.
- (iii) Case be put up in the next meeting alongwith the conclusive report of PPCB, PCCF & DOA.

2. M/s Om Sons Marketing Private Ltd (Unit-II), Village Sangat, Tehsil & District Bathinda
- The case was considered by the SCA-cum-SAC in its 92nd meeting held on 30.03.2016, wherein the SCA-cum-SAC observed that DOI, DOF, CTP, DHS, DOA, IMD & CFO have recommended for grant of site clearance to the industry.
- Punjab Pollution Control Board vide letter No. 996-97 dated 01.03.2016 has informed that the industry has been asked to submit the following documents/clarification before taking further necessary action in the matter:-
 1. The industry has submitted an agreement of 38 kanals 18 marlas of the land to be taken on lease for 6 years, to be developed under plantation, but it does not consist of any land numbers i.e. khasra No./killa Nos as well as its location on the Aks Sajra/Map in reference to the location of the industry.
 2. The industry has not given details of land to be used for disposal of fuel ash @ 100 TPD in scientific manner which will be generated from burning of fuel in boilers.
 3. The industry has not submitted layout plan showing the existing unit, proposed expansion unit and the plantation area for both units with different colours in concerned khasra Nos. etc.
 - PCCF vide letter no. 12070 dated 03.03.2016 has informed that the capacity of unit is to be increased and 40 MW power plant is to be set up in the existing premises of the industry for which no forest land and trees are affected. However, the PCCF has further informed the industry has applied to the Forest Department for getting permission under Forest (Conservation) Act, 1980 for laying pipeline. The PCCF has also informed that in this case the Nodal Officer has raised some observations, which were conveyed to the industry vide letter No. FCA/1980/222/2015/5775 dated 31.10.2015. The industry has not replied for the same, so far.

After detailed discussions it was decided to convey above mentioned observations of PPCB & Forest Department to the industry for compliance and to ask it to submit compliance report in this regard, directly to the concerned departments under intimation to SCA-cum-SAC. Further, it was decided that the case be deferred till the industry submits the compliance report of the above mentioned observations of PPCB & PCCF.

Thereafter, the industry submits the reply to the observations raised by PPCB & PCCF and the case will be considered in the next meeting of SCA-cum-SAC.
3. M/s Pritika Industries
- The case was considered by the SCA-cum-SAC in its

- The case stands recommended by all the member departments except DOA and CFO.
- PBIP vide its E-mail dated 31.05.2016 has sent the comments of Local Govt. (CFO), wherein it has been mentioned that the project report / other documents submitted by M/s Pritika Industries Limited have been examined and it is found that the industry has not proposed fire-fighting arrangements as per Punjab Fire Brigade Rules. The CFO has recommended that CSA/SAC clearance may not be granted to the industry till it submits the proper documents for installation of fire-fighting arrangements, as per Punjab Fire Brigade Rules.
- Final comments from DOA are awaited. However, the representative of DOA informed that the case is pending with District Advisory Committee, Ropar. He further assured that the recommendations of the department will be sent within 10 days, positively.

After discussions, following decisions were taken:

- (i) PBIP will get the required documents from the industry and also send the fresh recommendations of the Department of Local Government (CFO) within a week, positively.
- (ii) The representative of DOA has been asked to expedite the matter and will send the final recommendations in the matter within 10 days, positively.
- (iii) Defer the case and be put up in the next meeting of SCA-cum-SAC with the final recommendations of Department of Local Govt (CFO) & DOA.

4. M/s Symmetrix Biotech
Pvt. Ltd., Plot No. 16,

The case was considered by the SCA-cum-SAC in its 93rd meeting held on 06.06.2016, wherein the SCA-cum-SAC observed that:

- The case stands recommended by all the member departments except DOA and CFO.
- PBIP vide its E-mail dated 31.05.2016 has sent the comments of Department of Local Govt. (CFO), wherein it has been mentioned that from the perusal of the project report and physical inspection of the proposed site by the Assistant Divisional Fire Officer, the following observations were made:
 1. The company has not proposed the Fire Fighting Arrangements as per the Punjab Fire Brigade Rules.
 2. The company has not left open space

within the plot as per the National Building Code of India 2005, for the free movement of fire tenders around the buildings.

The CFO recommended that CSA clearance may not be granted to the industry till the industry comply with the provisions of Punjab Fire Brigade Rules.

- Final comments from DOA are awaited. However, the representative of DOA informed that the case is pending at field level. He further assured that the recommendations of the department will be sent within 10 days, positively.

After discussions, following decisions were taken:

- (i) PBIP will get the required documents from the industry and will send the fresh recommendations of the Department of Local Government (CFO) within 10 days, positively.
- (ii) The representative of DOA was directed to expedite the matter and to send the final recommendations in the matter within 10 days, positively.
- (iii) Defer the case and be put up in the next meeting of SCA-cum-SAC alongwith the final recommendations of Department of Local Govt. (CFO) & DOA.

5. M/s Akzo Nobel India Ltd., (ICI India Ltd), Plot No. A-42, Phase-VIII-B, Industrial Focal Point, Mohali
- The case was considered by the SCA-cum-SAC in its 93rd meeting held on 06.06.2016, wherein the SCA-cum-SAC observed that:
- DOF, IMD & DHS have recommended for grant of site clearance to the industry.
 - PPCB has also recommended for grant of site clearance to the industry vide letter No. 3255 dated 03.06.2016.
 - Comments from CFO are awaited.
 - Comments from DOI are also awaited. However, during discussions, representative of DOI informed that the case file has been put up to the Director and the comments of the department will be sent within 2-3 days, positively.
 - Final comments from DOA are awaited. However, the representative of DOA assured informed that the recommendations of the department will be sent within 10 days, positively.

After discussions, following decisions were taken:

- (i) The representatives of DOI & DOA were directed to expedite the matter and to send the

final recommendations in the matter within a week, positively.

- (ii) CFO be directed to send the comments within 10 days, positively.
- (iii) Defer the case and be put up in the next meeting of SCA-cum-SAC alongwith the final recommendations of DOI, DOA & CFO.

- At present, the case stands recommended by PPCB, DOI, DOF, CTP, IMD, DHS & CFO.
- The PCCF vide letter No. 5087 dated 26.05.2016 has informed that the Ministry of Environment, Forests & Climate Change, Northern Regional Office, Chandigarh vide letter No. 9PBB363/2016-CHA dated 18.05.2016 has raised the following observations for which the industry has not replied as yet:
 - (i) Copy of NOC issued by Punjab Pollution Control Board
 - (ii) Copy of environmental clearance issued by MoEF
 - (iii) Revised layout plan specifying the area
 - (iv) Certificate regarding complete settlement of rights in terms of the Scheduled Tribes & Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006.

During discussions, representative of Punjab Pollution Control Board cleared that the NOC by the Punjab Pollution Control Board will be issued only after the issuance of site clearance by the SCA-cum-SAC and the grant of environmental clearance by Ministry of Environment, Forests & Climate Change is not linked with the case of site clearance to be issued by the SCA-cum-SAC.

After discussions, it was decided that PCCF will get the requisite documents from the industry and will send its final report/recommendations in the matter to SCA-cum-SAC within 15 days. It was further decided to put up the case in the next meeting alongwith the final report of PCCF.

3. M/s K.C. Steel Casting & Alloys, Village Kumbh, Amloh Road, Mandi Gobindgarh, District Fatehgarh Sahib

The case was considered by the SCA-cum-SAC in its 93rd meeting held on 06.06.2016, wherein the SCA-cum-SAC observed that:

 - The case stands recommended by PPCB, DOI, DOF, CTP, IMD, PCCF, CFO & DHS.
 - DOA vide letter No. 1090 dated 30.05.2016 has informed that the case is pending with District Advisory Committee, Fatehgarh Sahib. The representative of DOA assured that the recommendations of the department will be sent within 7 days.

After discussions, representative of DOA was directed to expedite the matter & to send the final recommendations in the matter within a week, positively. It was further decided to defer the case and be put up in the next meeting of SCA-cum-SAC alongwith the final recommendations of DOA.

4. M/s Sukhjit Mega Food

The case was considered by the SCA-cum-SAC in its

Park & Infra Ltd., 93rd meeting held on 06.06.2016, wherein the SCA-cum-Village Rehana Jattan, SAC observed that the case stands recommended by all Tehsil Phagwara, District comments except DOA. DOA vide letter No. 427/JDA Kapurthala (HG) dated 04.03.2016 has informed that the Secretary to Govt. of Punjab, Department of Irrigation, Punjab was written by their department to take up the matter with CGWA for the exemption from guidelines/criteria of Central Ground Water Authority (CGWA) for groundwater abstraction for the project.

- No exemption letter has been received from the CGWA. After discussions, it was decided that the case be deferred and case be put up in the next meeting of SCA-cum-SAC.
- DOA vide letter No. 1090 dated 30.05.2016 has informed that the case is pending with GOI. D.O. from ACS (D), Punjab were sent to Secretary Food Processing, GoI and Chairman CGWB. During the meeting, representative of DOA informed that the recommendations of their department will be sent at the earliest possible.

After discussions, it was decided to defer the case and be put up in the next meeting of SCA-cum-SAC alongwith the report of DOA.

5. M/s Singla Solvent, The case was considered by the SCA-cum-SAC in its Village Maur Nabha, 93rd meeting held on 06.06.2016, wherein the SCA-cum-Pakho Kanchian Road, SAC observed that Tehsil Tapa, District Barnala

- DOF, PPCB, IMD, DHS & CFO have recommended for grant of site clearance to the industry.
- CTP & DOA have also recommended for grant of site clearance to the industry vide letter Nos. 2398/CTP/(Pb)/SB-134 dated 26.05.2016 and nos.1133 JDA (HG) dated 01.06.2016, respectively.
- Comments from DOI are awaited. However, during the discussions representative of DOI informed that the case is under process and the final report will be sent within 2-3 days.
- PCCF vide letter No. 1225 dated 12.05.2016 has informed that 57.69 sqm of forest land is affected with the approach to the industry from the Pakho-Tapa Road and the user agency is required to obtain permission from Govt. of India, Ministry of Environment & Forests, under the Forest (Conservation) Act, 1980. The PCCF informed that the user agency has applied for obtaining the requisite permission and the industry has not replied to the observations made by PCCF.

After detailed discussions it was decided:

- (i) To ask the industry to comply with observations raised by the Forest Department and send the reply to the PCCF under intimation to SCA-cum-SAC.
- (ii) The representative of PCCF was directed to get the reply of observations from the industry and to send the conclusive report within 15 days, positively.
- (iii) Representative of DOI was directed to send the comments of the department within 3 days, positively.
- (iii) The case be put up in the next meeting alongwith the report of DOI & PCCF.

6. M/s Bindi Industries, Village Dangora, District Ludhiana
 The case was considered by the SCA-cum-SAC in its 93rd meeting held on 06.06.2016, wherein the SCA-cum-SAC observed that DOF, IMD, PCCF, DHS & CFO have recommended for grant of site clearance to the industry.

- PPCB has recommended the case subject to the condition that the site is cleared by the Department of Town & Country Planning.
- DOI & DOA has also recommended for grant of site clearance to the industry vide letter No. 7000-A dated 06.06.2016 and No. 1181 dated 02.06.2016, respectively.
- CTP, Punjab vide letter No. 2637 CTP (Pb) SL-195 dated 03.06.2016 has informed that the approach to the industry is to be taken from 22 ft wide link road and as per provisions of Master Plan Ludhiana this road is to be widened upto 80 ft wide. As such, the applicant will leave 29 ft wide land from its own land along the approach road for widening the existing road upto 80 ft wide.

CTP has recommended that the case of the industry may be considered only after the industry leave 29 ft wide land from its own land along the approach road for widening the existing road upto 80 ft wide.

After detailed discussions it was decided to convey above mentioned observations of CTP to the industry for compliance and to ask it to submit compliance report in this regard, directly to the CTP, Punjab under intimation to SCA-cum-SAC. It was further decided to defer the case till the industry submits the compliance report of the above mentioned observation of CTP.
