Subject: Minutes of 1st meeting of District Environment Committee held under the Chairmanship of Deputy Commissioner, SAS Nagar on 09.12.2019 at 10:00 A.M at Committee Room, SAS Nagar.

The list of participants is attached as **Annexure-A**.

At the outset, the Environmental Engineer, PPCB welcome all the officers. The Environment Engineer briefed that the Department of Science Technology and Environment vide its letter no. 10/352/2018-STE(5)/1605949/1 dated 31.10.2019 has constituted a District Environment Committee in compliance to the Hon'ble NGT order dated 26.09.2019 in OA 360 of 2018 titled as Shree Nath Sharma V/s Union of India & Others.

He further briefed that the constituted committee consists of the following members:

The participants were informed that District Environment Committee shall prepare District Environment Plan and its revision from time to time w.r.t various areas of Environment, particularly all types of waste management, non-attainment cities i.e Derabassi, status of STPs and reuse of treated water, illegal sand mining, ground water abstraction/contamination and recharging, air pollution including noise etc. The committee shall prepare District Plans for climate change and Mission Tandrust Punjab and to revise the same from time to time. The committee shall review the progress of the District Environment Plans and it will identify the person responsible for violation of law and norms relating to water pollution, air pollution, noise pollution and waste management. The Environmental Engineer apprised about the other functions to be carried out by the committee and the powers vested with the committee in detail to all the participants of the meeting.

After detailed deliberation, the Chairperson decided that each department shall depute a Nodal Officer for the committee not below the rank of Sub-divisional Engineer and shall inform the same to the Punjab Pollution Control Board through E-mail: eenodal@yahoo.in. It was also decided by the chairperson that all the officers of the ULBs in particular, to update the model District Environment Plan prepared by the CPCB within next 7 days and to submit the same to ADC (D). Member Secretary of the District Environment Committee, Environment Engineer, Punjab Pollution Control Board was directed to send the Performa District Environment Plan (DEP) to all the members through E-mail

The meeting ended with vote of thanks to the Chair.
