

Documents in case of new establishment (CTE/ CTO) of e-waste management facility

- A) Documents as given on the website of the Board www.ppcb.gov.in for grant of fresh NOC / CTO under the Water Act, 1974 & Air Act, 1981.
- B) Compliance of responsibilities outlined under E-Waste (Management) Rules, 2016 as amended from time to time for manufacturer, dismantler, recyclers and refurbishers.
- C) Compliance of standards or guidelines issued by CPCB for environmentally sound dismantling, recycling and refurbishing of E-waste, with special reference to space requirement, process requirements, air pollution control devices etc.

For Fresh authorization under E-Waste (Management) Rules, 2016

- a) Consent to establish granted by the State Pollution Control Board under the Water (Prevention and Control of Pollution) Act, 1974, (sec 25 of 1974) and the Air (Prevention and Control of Pollution) Act, 1981 (sec 21 of 1981). (for manufacturer, dismantler, recyclers and refurbishers). Compliance report w.r.t. point (B) & (C) may be also be given.
- b) Certificate of registration issued by the District Industries Centre or any other government agency authorised in this regard. (For dismantler, recyclers and refurbishers)
- c) Proof of installed capacity of plant and machinery issued by the District Industries Centre or any other government agency authorised in this behalf. (For dismantler, recyclers and refurbishers).
- d) Treatment and disposal of hazardous wastes as applicable. (For dismantler or recyclers, refurbishers).
- e) Compliance of responsibilities outlined under E-Waste (Management) Rules, 2016 as amended from time to time (for manufacturer, dismantler, recyclers and refurbishers).

For Renewal of authorization under E-Waste (Management) Rules, 2016

- a) Compliance of conditions of consents to operate granted by the State Pollution Control Board under the Water (Prevention and Control of Pollution) Act, 1974, (sec 25 of 1974) and the Air (Prevention and Control of Pollution) Act, 1981 (sec 21 of 1981). (for manufacturer, dismantler, recyclers and refurbishers).
- b) Compliance of conditions of authorization granted under the HWM Rules, 2016.
- c) Annual return in Form-3 as given in E-Waste (Management) Rules, 2016. (for manufacturer, dismantler, recyclers and refurbishers).

- d) In case of renewal / old unit who has not obtained NOC from the Board, a certificate of compliance of effluent and emission standards, treatment and disposal of hazardous waste as applicable. (for dismantler or recyclers, refurbishers).
- e) Compliance of standards or guidelines issued by CPCB for environmentally sound dismantling, recycling and refurbishing of E-waste, with special reference to space requirement, process requirements, air pollution control devices etc.

Note:- Provided that any person authorised or registered under the provisions of the Hazardous Wastes (Management, Handling and Transboundary Movements) Rules, 2008, and the E-waste (Management & Handling) Rules, 2011, prior to the date of coming into force of these rules shall not be required to make an application for authorisation, till the period of expiry of such authorisation or registration.
