

- 2) *The Executive Engineer, Punjab Mandi Board, Faridkot shall also be added as stakeholder department to implement the plantation activity of the Environment Plan.*
- 3) *All the stakeholder departments shall submit the progress of the activities related to their departments and compliance of decisions of 1st meeting in writing within 07 days.*
- 4) *All the stakeholder departments shall peruse the timelines and shall submit logical revised timelines (with proper reasons) if required in writing to PPCB through email at ppcbfdk@yahoo.com, within 07 days.*
- 5) *All the stakeholder departments shall submit the progress to PPCB latest by first week of every month through email.*

The Chairperson after taking stock of all the information provided / deliberations in the matter decided that all the Departments shall adhere with the timelines of the activities mentioned in the District Environment Plan.
