Proceedings of the public hearing conducted on 30.08.2024 in connection with application filed by M/s Garg Furance Ltd., for conduct of public hearing for obtaining environmental clearance under EIA notification dated 14.09.2006, for expansion of the existing unit located at V.P.O. Jugiana, Kanganwal Road, G.T. Road, Ludhiana.

It is intimated that the subject cited industry is an existing unit located in an area of 7.368 acres in the revenue estate of V.P.O. Jugiana, Kanganwal Road, G.T. Road, Ludhiana and is engaged in the manufacturing of ingots @ 60 TPD and rolled products (wire rod/flat/square/round) @ 115 TPD by installing an induction furnace of 6 ton/heat capacity alongwith 2 No. Rolling Mills. Now, the industry has proposed to increase its manufacturing capacity of steel ingots/billets, angles, channels, rounds, hexa square, TMT bars, flats, wire rod @ 1,26,000 TPA (Total after expansion) in its existing premises by replacing existing 6 ton/heat capacity induction furnace with 1 no. induction furnace of 15 Ton/heat capacity and to install another induction furnace of 15 Ton/heat capacity besides 2 No. existing Rolling Mills. The project is covered under the EIA notification No. S.O. 1533 (E) dated 14.9.2006 issued by Ministry of Environment, Forest & Climate Change, (MoEF&CC), Govt. of India, New Delhi and thus, the industry is required to obtain Environmental Clearance from MoEF&CC, New Delhi. As a part of the procedure for seeking environmental clearance, as notified by MoEF&CC, the project proponent has prepared draft EIA study report of the proposed project based on the Terms of Reference issued by the MoEF&CC, New Delhi, vide No. IA-J-11011/177/2023-IA-II(IND-I) dated 30.05.2023. The industry had submitted draft EIA study report to the Board and had requested for conduct of public hearing of this project.

Office Memorandum dated 14.09.2020, the Board fixed the date of public hearing as 30.08.2024. Public notices were published in two daily newspapers namely 'Times of India' & 'Rozana Spokesman' on 30.07.2024 for getting responses from public and intimating date, time & venue of public hearing.
