Subject:- Regarding inspection/visit reports/surprise checks.

The Board had issued office order no. 136 dtd. 17.3.2016 regarding uploading of inspection/visit reports by the visiting officers within 48 hours of his/her visit in view of Business Reform Action Plan, 2016 for States /UTs for enabling Ease of Doing Business to the entrepreneurs.

Now, Govt. of India, Department of Industrial Policy and Promotion, Ministry of Commerce and Industry has raised certain clarification regarding the Acts to be covered.

In view of the above, the procedure laid down earlier with regard to the uploading of inspection reports of the industries is modified as under: -

"The inspection/visit reports for processing the NOC/ consent application of the industries as well as compliance under Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention & Control of Pollution) Act, 1981 and Hazardous & Other Wastes(Management & Transboundary Movement) Rules, 2016 shall be uploaded online through Online Consent Management & Monitoring System (OCMMS) by the visiting officers within 48 hours of his/her visit".

These orders shall supersede the earlier office order no. 136 dtd. 17.3.2016 and shall come into force with immediate effect.
