Proceedings of the public hearing conducted on 11.03.2024 in connection with application filed by Executive Engineer-cum-District Mining Officer, SBS Nagar for obtaining environmental clearance under EIA notification dated 14.09.2006 for mining of minor minerals in the revenue estate of Village Jaloke & Kot Budha, Tehsil Patti, District Tarn Taran.

It is intimated that the subject cited project proponent has applied to SEIAA, Punjab for obtaining environmental clearance for mining of minor minerals @ 3,96,980 TPA in an area of 29.32 hectares situated in the revenue estate of Village Jaloke & Kot Budha, Tehsil Patti, District Tarn Taran. The project is covered under Ministry of Environment Forest & Climate Change (MoEF&CC), Govt. of India, notification no. S.O. 1533 (E) dated 14.09.2006 and thus is required to obtain environmental clearance from SEIAA, Punjab. The 'Terms of Reference' for preparing draft EIA study report for the said project have been prescribed by the SEIAA, Punjab vide No. SEIAA/MS/2023/1645 dated 03.10.2023. Accordingly, the project proponent had submitted draft rapid EIA study report alongwith summary report of the same to the Punjab Pollution Control Board and requested for conduct of the public hearing for the proposed project.


In compliance to the provisions laid down in the EIA notification dated 14.9.2006, the date of public hearing for the project was fixed by the Board as 15.01.2024 in Gurudwara Sahib, Village Jaloke, District Tarn Taran and the public notice of 30 days in this regard was issued in two daily newspapers namely 'The Tribune' and 'Jagbani' on 13.12.2023 for getting responses from public and intimating date, time & venue of the public hearing. A copy of the said notices is enclosed herewith as **Annexure-I**. The public announcements and banners were displayed in the vicinity/nearby villages by the Board to give the wide publicity of the public hearing. Thereafter, public hearing for the said project was organized on 15.01.2024 in Gurudwara Sahib, Village Jaloke, Tehsil Patti, District Tarn

Taran under the supervision of Sh. Rajesh Sharma PCS, Sub Divisional Magistrate, Patti, District Tarn Taran. As per the proceedings, residents of the village Jaloke and adjoining villages present at the site resist to conduct the public hearing due to their issues regarding land/revenue and accordingly the public hearing at village Jaloke was not conducted. The Supervising-cum-Presiding Officer has directed to initiate the process for reschedule the public hearing of the project.

In view of the recommendations of Supervising-cum-Presiding Officer and recommendations of Environmental Engineer, Regional Office, Amritsar, the date of public hearing for the project was refixed by the Board as 11.03.2024 in Gurudwara Sahib, Village Jaloke, Tehsil Patti, District Tarn Taran and the public notice of 15 days in this regard was issued in the same newspaper in which the initially public notice was given i.e. 'The Tribune' and 'Jagbani' on 22.02.2024 for getting responses from public and intimating time, date & venue of the public hearing. A copy of the said notices is enclosed herewith as **Annexure-II**. The public hearing was conducted on 11.03.2024, which was supervised & presided over by the Sub Divisional Magistrate, Patti, District Tarn Taran in the presence of Environmental Engineer & Assistant Environmental Engineer, Punjab Pollution Control Board, Regional Office, Amritsar. The entire process of the said hearing was videographed. A copy of the attendance sheet containing the details of persons, who attended the said hearing alongwith copy of the Pen drive containing video recording, is enclosed herewith as **Annexure-III & IV**, respectively.

The proceedings of the public hearing dated 11.03.2024 reflecting the views and concerns expressed during the public hearing, duly signed by the Sub Divisional Magistrate, Patti, District Tarn Taran and Environmental Engineer & Assistant Environmental Engineer, Punjab Pollution Control Board, Regional Office, Amritsar, are enclosed herewith as Annexure-V further necessary action at the end of the SEIAA, Punjab.


