Subject: Proceedings of the public hearing conducted on 08.11.2024 in connection with application filed by M/s K.S. Alloys, for conduct of public hearing for expansion of the existing unit located in the revenue estate of Village Kumbh, Mandi Gobindgarh, Distt. Fatehgarh Sahib.

It is intimated that the subject cited industry is an existing unit located in an area of 3.9375 acres in the revenue estate of Village Kumbh, Amloh Road, Mandi Gobindgarh, Distt. Fatehgarh Sahib and is engaged in the manufacturing of Steel ingots/billets/rolled products (Round, square, flats & angles) @ 84 TPD or ERW pipes @ 80 TPD by installing an induction furnace of 7 ton/heat capacity, 1 No. Rolling Mill & pipe plant. Now, the industry has proposed to increase its manufacturing capacity of steel ingots/billets/rolled products (Round, square, flats & angles)/ERW Pipes to 410 TPD (1,43,500 TPA) (Total after expansion) in the existing premises by replacing existing induction furnace of 7 ton/heat capacity with 1 no. induction furnace of 12 Ton/heat capacity and to install another induction furnace of 15 ton/heat capacity alongwith already existing installed Rolling Mill & pipe plant. The project is covered under the EIA notification No. S.O. 1533 (E) dated 14.9.2006 issued by Ministry of Environment, Forest & Climate Change, (MoEF&CC), Govt. of India, New Delhi and thus, the industry is required to obtain Environmental Clearance from State Environment Impact Assessment Authority (SEIAA), Punjab. As a part of the procedure for seeking environmental clearance, as notified by MoEF&CC, the project proponent has prepared draft EIA study report of the proposed project based on the Terms of

Reference issued by the SEIAA, Punjab, vide No. SEIAA/MS/2023/2008 dated 23.11.2023. The industry had submitted draft EIA study report and other required documents to the Board and had requested for conduct of public hearing of this project.

In compliance to the provisions of the EIA notification dated 14.9.2006 & Office Memorandum dated 14.09.2020, the date of public hearing was fixed as 08.11.2024. Public notices were published in two daily newspapers namely 'The Indian Express' and 'Punjabi Tribune' on 07.10.2024 for getting responses from public and intimating date, time & venue of the public hearing. The copies of the said notices are enclosed herewith as **Annexure-I**. The public announcements and banners were displayed in the vicinity / nearby villages to give the wide publicity of the public hearing by the Board. Thereafter, public hearing for the said project was conducted on 08.11.2024. The public hearing process was supervised & presided over by the Sub Divisional Magistrate, Fatehgarh Sahib in the presence of Environmental Engineer & Asstt. Environmental Engineer, PPCB Regional Office, Fatehgarh Sahib. The public hearing was attended by 82 persons and entire process of the said hearing was videographed. A copy of the attendance containing the details of persons, who attended the said hearing along with copy of the Pen drive containing video recording & album of photos, are enclosed herewith as **Annexure-II & III**, respectively.
