Proceedings of the public hearing conducted on 22.10.2024 in connection with application filed by M/s Maggo Chemical & Pharmaceutical Unit-2, for obtaining environmental clearance under EIA notification dated 14.09.2006, for setting up of a new unit for the manufacturing of technical grade pesticides @ 1011 MTPA in the revenue estate of Vill. Behra (Gulabgarh Behra Road), Tehsil Dera Bassi, District SAS Nagar.

It is intimated that M/s Maggo Chemical & Pharmaceutical Unit-2, has proposed to set up a new unit for the manufacturing of technical grade pesticides @ 1011 MTPA (Insecticides @ 565 MT/Annum, Fungicides @ 328 MT/Annum & Herbicides @ 118 MT/Annum) in an area of 5.97 acres in the revenue estate of Vill. Behra (Gulabgarh Behra Road), Tensil Dera Bassi, District SAS Nagar. The project is covered under the EIA notification No. S.O. 1533 (E) dated 14.9.2006 issued by Ministry of Environment, Forest & Climate Change, (MoEF&CC), Govt. of India, New Delhi and thus, the industry is required to obtain Environmental Clearance from MoEF&CC, New Delhi. As a part of the procedure for seeking environmental clearance, as notified by MoEF&CC, the project proponent has prepared draft EIA study report of the proposed project based on the Terms of Reference issued by the MoEF&CC, New Delhi, vide No. IA-J-11011/105/2024-IA-II(I) dated 15.03.2024. The industry had submitted draft EIA study report to the Board and had requested for conduct of public hearing of this project.

Office Memorandum dated 14.09.2020, the Board fixed the date of public neuring as 22.10.2024. Public notices were published in two daily newspapers namely 'The Indian Express' & 'Punjabi Tribune' on 19.09.2024 for getting responses from public and intimating date, time & venue of public hearing. The copies of the said notices are enclosed here with as Annexure-I. The public announcements and banners were displayed in the vicinity / nearby villages to give the wide publicity of the public hearing, by the Board.
