Agenda No. 1.1 Review of monitoring of Water Quality of Rivers

1. Status of Sewage Generation & Treatment

The Committee was apprised regarding the sewage generation in Punjab, available infrastructure for the treatment, the gap and the infrastructure proposed to be set up to address the gap for the management of domestic sewage in the State.

2. Status of water quality of polluted river stretches as per CPCB report 2022

- (i) The Committee was appraised that regarding the 5 polluted river stretches as per CPCB Report 2022, PPCB was asked to take up the matter with CPCB for 2 stretches namely Sirsa & Swan which primarily falls in H.P.
- (ii) PPCB informed that as per the discussions held with PPCB, a joint meeting will be held with Himachal Pradesh regarding the issue of River Swan and Sirsa.

3. Development of Low-Cost Sensor to monitor various parameters by IIT Ropar.

- (i) PPCB informed that 1 node is functional and operative & remaining 4 nodes would be made functional within 2 months.
- (ii) The Committee directed PPCB to take necessary actions regarding the matter and all the nodes shall be made functional by the next meeting likely to be held in March, 2024.

4. Setting up of Integrated Dashboard for online monitoring

The Committee directed PPCB to take necessary action regarding the matter and update the current status and the action taken in the next meeting of the Committee.

Agenda No. 1.2 Review of Monitoring of functioning of STPs in the catchment area

1. Status of STP Monitoring

- (i) The Committee took serious note of STPs which are regularly failing and directed DLG and PWSSB to take stringent action against the officers responsible for failure of STPs.
- (ii) It was further directed that Deputy Commissioners may take regular meetings to reduce the non-compliance of the STPs under their respective jurisdiction of District failing especially due to F-Coli.

Agenda No. 1.3 Review of monitoring of functioning of CETPs & ETPs in the catchment area of the rivers

1. Status of CETP monitoring

- (i) PPCB informed that the Pre-Treatment standards are being notified by them so that the non-compliance of CETPs is reduced once the pre-treatment standards are met by CETPs.
- (ii) The Committee directed PPCB to initiate actions against the SPVs of the non-compliant CETPs failed to achieve the prescribed standards.

2. Status of ETP Monitoring

- (i) The Committee noted the progress.
- (ii) The Committee directed ADC's of all Districts to randomly select 10% of the total ETPs for joint monitoring with PPCB on monthly basis.

(i) MC, Jalandhar informed that work for CETP of 0.15 MLD CETP at Focal Point, Jalandhar is stopped due to a Writ petition in Hon'ble High Court. Next date of hearing 24.02.2024.

- Committee directed to update the status after next date of hearing.
- (ii) DIC informed that the process of retendering has been restarted for 5 MLD of CETP for Leather Complex, Jalandhar by DPIIT.

Agenda No.1.6 Progress of setting up of ETPs/ Biogas Plants for Dairy Waste

1. Setting up of CBG Plant at Haibowal Dairy Complex, Ludhiana

(i) PEDA informed that for 300 Tons Green Hydrogen Plant for Haibowal dairy complex, the tender would be awarded within 2 weeks.

2. Setting up of CBG Plant at Tajpur Dairy Complex, Ludhiana

- (i) The Committee noted the progress.
- (ii) PEDA informed that the site plan has not been approved by GLADA. The committee directed GLADA to approve the plan at the earliest so that the work be completed as per the timelines given by the Deptt.

- (i) The Committee noted that the updated District Environment Plans for the financial year 2023-24 of all 23 districts have been submitted to CPCB in the month of September, 2023.
