**Subject: Minutes of 10th meeting of District Environment Committee held on 26/07/2022 at 11:00 AM at District Administrative Complex, SAS Nagar under the Chairmanship of Deputy Commissioner, SAS Nagar to review the progress of the activities mentioned in the District Environment Plan for SAS Nagar.**

The list of officers / officials, who attended the meeting, is attached herewith as **Annexure-1**.

At the outset, Environmental Engineer, PPCB, RO, Mohali brought out the agenda points of the meeting as under:

**(A) District Environment Plan (DEP) for SAS Nagar**

Environmental Engineer, Punjab Pollution Control Board informed that worthy Secretary, Science Technology and Environment had desired that latest data upto 30.06.2022 shall be fed in the District Environment Plan and updated District Environment Plan be submitted to him immediately. Accordingly, vide email dated 11.07.2022 it was requested to update the latest status pertaining to your department regarding Gaps, Action Plan and Timelines as on 30.06.2022 and sent through email at eenodal@yahoo.in by 15.07.2022, positively. However data of only MC Mohali, MC Zirakpur, MC Naya Gaon, MC Kurali, MC, Banur, MC Derabassi, MC Lalru, GMADA, MC Kharar, PSIEC, Transport department, Director of Factories, GMDIC, Soil Conservation department, Civil Surgeon, Agriculture department, Water Resources cum Drainage Department, and PWSSB has been received. Data of DDPO, PWD, Labour Department, Forest Department, Police, PWRDA is still pending.

***DC, SAS Nagar directed all the concerned departments to send the requisite data within 02 days, so that updated DEP can be prepared and submitted to Worthy Secretary, Science Technology and Environment.***

**(B) Prohibition/Ban on Manufacturing, stocking, sale, distribution, use and import of Single use plastic items:**

Environmental Engineer, Punjab Pollution Control Board informed that MoEFCC has notified PWM Amendment Rules, 2021 vide GSR 571(E) dated 12.08.2021 as per which, the manufacture, import, stocking, distribution, sale and use of following single use plastic, including polystyrene and expanded polystyrene, commodities shall be prohibited with effect from the 1st July, 2022:-

- (a) ear buds with plastic sticks, plastic sticks for balloons, plastic flags, candy sticks, ice-cream sticks, polystyrene [Thermocol] for decoration;
- (b) plates, cups, glasses, cutlery such as forks, spoons, knives, straw, trays, wrapping or packing films around sweet boxes, invitation cards, and cigarette packets, plastic or PVC banners less than 100 micron, stirrers.

Further, an awareness meeting was held under the Chairmanship of DC Mohali on 30.06.2022 wherein all the stakeholder departments were given presentation regarding their responsibility. DC Mohali had constituted teams for carrying out inspection of commercial establishments, industries etc. which are manufacturing, importing, stocking, distribution, selling and using banned SUP items.

He further informed that as per information provided by ULBs on Whatsapp Group, detail of inspections is as under:

1. **01.07.2022** – Inspections by the teams constituted by the DC, Mohali, were made in Zirakpur, Kurali, Derabassi, Mohali, Banur, Kharar and Shop keepers, stockists etc. were raided and banned SUP items were confiscated and Challans of shop keepers using banned plastic carry bags were done.
2. **02.07.2022** - Inspections by the teams constituted by the DC, Mohali, were made in Derabassi, Mohali, Kurali, Lalru and Banur and Shop keepers, stockists etc. were raided and banned SUP items were confiscated and Challans of shop keepers using banned plastic carry bags were done.
3. **03.07.2022** – Awareness campaign for using cloth bags for carrying vegetables and fruits at Sabji Mandi was carried out by PPCB and MC Mohali, in collaboration with M/s Utkarsh Global Foundation, at Sabji Mandi, phase-8, Mohali. Around 1000 cloth bags were distributed to the public.
4. **05.07.2022** - Inspections by the teams constituted by the DC, Mohali, were made in Zirakpur, Mohali and Shop keepers, stockists etc. were raided and banned SUP items were confiscated and Challans of shop keepers using banned plastic carry bags were done.
5. **11.07.2022** – Inspection by the teams constituted by the DC, Mohali were made in sector 70 Sabji Mandi and sector 58, shahi majra Sabji Mandi. During visit, Challans of 2 no. sabji vendors were done and plastic carry bags @ 5 to 6 Kgs were confiscated.
6. **19.07.2022** – Awareness campaign for using cloth bags for carrying vegetables was carried out in collaboration with M/s Eco Conserve Foundation, Chandigarh, at Zirakpur. Around 500 cloth bags were distributed to the public.
7. **19.07.2022** – A meeting with Kharar Kiryana Merchants Association was held in MC Kharar office and the association was made aware of the banned SUP items.

EE, PPCB also apprised the chair that PPCB have issued closure directions to 2 no. industries (M/s Saksham Enterprises and G.S. Industries, Phase-9, Mohali) which were found manufacturing banned plastic carry bags and have imposed Environmental compensations of Rs. 2 lakh on the industries. Both the industries have deposited Environmental Compensation amounting to Rs. 2 lakh, each.

DC, SAS Nagar decided as under :

1. All the ULBs to increase the frequency of checking and inspections in the district w.r.t. Single Use Plastic (SUP) Ban and submit details of inspections, challaning etc to PPCB within 7 days.
2. He also asked that PPCB and ULBs shall identify & get in touch with local NGOs and self help groups, so as to create awareness among masses regarding SUP ban and also carry out activities such as distribution of cloth bags & other alternatives to Single Use Plastic items. PPCB will convene a meeting with Local NGOs and self help groups under ADC (UD) within 7 days.
3. All the departments to stop using Single Use Plastic items in government offices and declare their offices Single Use Plastic free and submit compliance in this regard before next meeting.
4. A short documentary on ban of single use plastic shall be prepared by PPCB which shall be displayed in Cinema halls before start of movie.
5. A research centre for providing technical help regarding technologies for manufacturing alternative of single use plastic and type of single use plastic available etc. shall be setup in the district. PPCB shall coordinate with the educational institution for setting up of centre.
6. Awareness activities regarding ban on single use plastic shall be carried out in schools and colleges.

**(C) Action Plan for Clean Ghaggar**

Environmental Engineer brought out that there are presently 10 STPs installed in district Mohali with total treatment capacity of 88.3MLD. The status of these 10 STPs are as under:

Environmental Engineer brought out that 14 no. of new STPs are proposed to be constructed in district Mohali. The status of these 14 STPs is as under:

- **5 no. STP of capacity of 1.5 MLD, 1 MLD, 0.15 MLD, 0.3 MLD and 0.3 MLD has been proposed at Lalru** –During last meeting, PWSSB informed the status of STPs as under :
  - a. The work of 1 MLD STP is in progress and 10% work has been completed. Time line for completion is 31.03.2023.
  - b. DNIT for 1.5 MLD STP is under approval and land for the same is yet to be handed over by MC. Time line for completion is 31.12.2023.
  - c. DNIT for 0.15 MLD STP is under approval. Time line for completion is 30.09.2023.
  - d. DNIT for 0.30 MLD STP is under approval. Time line for completion is 30.09.2023.
  - e. DNIT for 0.30 MLD STP is under approval. Time line for completion is 30.09.2023.

- **2 no. STPs of capacity of 2 MLD each has been proposed at Derabassi-** During last meeting, PWSSB informed the status of STPs as under :
  - a. 3 times tender call for STPs at Meerpur and Issapur but no bid received. Again tender yet to be called. Time line for completion is 31.12.2023.
- **2 no. STPs of capacity of 0.5 MLD and 0.15 MLD has been proposed at Banur-** Two new STPs of capacity of 0.5 MLD and 0.15 MLD has been proposed at Banur. The work regarding construction of STP of capacity 0.5 MLD has been completed & is under stabilization. The DNIT for the STP of 0.15 MLD has been prepared and sent to Competent Authority for approval.
- **1 no. STP of capacity of 17 MLD has been proposed at Zirakpur-** During last meeting, PWSSB informed that work for setting up of STP has been held up due to court case on STP proposed land.
- **1 no. STP of capacity 10 MLD at Aerocity, SAS Nagar Nagar and 15 MGD sector 83, Mohali** – Construction work of STPs at Aerocity and Sector83, Mohali are under progress. Time line for completion is 31.12.2022 and 30.06.2023 respectively.
- **1 no. STP of capacity 10 MLD has been proposed at Kharar** – The work of installation of 10 MLD STP at Kharar was allotted on 06.01.2022 to PWSSB. The site provided by MC Kharar lies in old dumping ground area. MC Kharar has handed over partially cleared site to PWSSB on 05.05.2022. Time line for completion is 31.12.2023.
- **1 no. STP of capacity 11 MLD proposed at Nayagaon-** During last meeting, the EO Naya Gaon submitted that the STP of capacity 10 MLD had been proposed for Naya Gaon but due to matter of land acquisition is pending in the Court, the project is getting delayed. EO was asked to follow up the matter personally in the SAS Nagar Hon'ble Court.

During meeting, it was decided as under:

- *PWSSB and ULBs shall carry out proper survey before planning/ establishing location of new STP and ensure STP of very small capacity are not being established in the district. PWSSB shall again workout the proposal of establishing single STP of big capacity instead of installing too many STPs of small capacity, for the STPs which are planned for the district.*
- *PWSSB, MC SAS Nagar, GMADA, PSIEC and all ULBs shall prepare population wise data for their respective cities/ towns w.r.t. current generation of wastewater and also future projections for the next 10 years and submit the same to PPCB within 10 days and PPCB will place the data during next meeting.*



- *EO, MC Nayagaon shall follow up take up the matter personally regarding land dispute over proposed site of STP, pending in the SAS Nagar Hon'ble Court & submit its updated status to PPCB within 10 days.*
- *PSIEC will share list of industries which are discharging their trade effluent into STP and PPCB will take action against such industries and bring action taken report during next meeting.*
- *PWSSB, MC, SAS Nagar, GMADA and PSIEC to ensure that STPs should run efficiently to achieve the standards prescribed by MoEF and CPCB/PPCB.*
- *All MC's and STP operated by PWSSB, PSIEC, GMADA shall maintain proper record for generation/ disposal of sludge in their respective STPs.*

**(D)** Environmental Engineer brought out that a meeting was taken by Hon'ble NGT Monitoring Committee on 30.05.2022 wherein following decisions were taken with regard to different activities mentioned in District Environment Plan, as under:

*1. The Monitoring Committee directed that 100% source segregation of solid waste by all the MCs and GMADA may be completed by 30.09.2022.*

- MC, Kharar has intimated that at present 95% source segregation achieved.
- GMADA has intimated that 100% source segregation will be achieved in GMADA approved colonies by 31.12.2022 and by 31.03.2023 in unregulated colonies.
- MC Derabassi has intimated that at present 100% source segregation achieved.
- MC Banur has intimated that at present 97 % source segregation achieved and remaining will be done by 31.12.2022.
- MC, Lalru has intimated that at present 95% source segregation achieved and remaining will be done by 31.12.2022.
- MC, Naya Gaon has intimated that at present 96% source segregation achieved and remaining will be done by 31.12.2022.
- MC, Zirakpur has intimated that at present 90% source segregation achieved and remaining will be done by 31.03.2023.

No status report received from MC Mohali and MC Kurali.

***DC decided that the remaining ULBs shall submit the information to PPCB by 28.07.2022.***

*2. The Monitoring Committee directed that the activities with regard to manual sweeping twice in a day time and once in night time may be carried out by all MCs and GMADA in residential and commercial area.*

No status report received from any ULBs and GMADA.

**DC decided that the ULBs and GMADA shall submit the information to PPCB by 28.07.2022.**

3. *The Monitoring Committee directed that mechanical sweeping machine may be procured by MC Derabassi by 30.09.2022. It was further directed that for suppression of dust generated during sweeping, treated wastewater of STPs may be utilized for sprinkling purposes in compliance to order of the Hon'ble National Green Tribunal.*

- MC Derabassi has intimated that it has procured mechanical sweeping machine.

No status report received from MC Mohali, Zirakpur, Kharar, Kurali, Banur, Lalru, Naya Gaon and GMADA.

**DC decided that the remaining ULBs and GMADA shall submit the information to PPCB by 28.07.2022.**

4. *The Monitoring Committee directed that waste deposition centres for domestic hazardous waste may be provided by MCs Kharar & Lalru by 31.07.2022 and GMADA by 31.01.2023. It was further directed that one additional compartment may be added in the compartmentalized rickshaw rehries/tri-cycles/solid waste collection vehicles for door to door collection of domestic hazardous waste by all the MCs and the waste so collected may be stored in the separate cabin at the material recovery site and same may be disposed off as per the provisions of the Hazardous & Other Wastes (Management & Trans boundary Movement) Rules, 2016/ Bio-Medical Waste Management Rules, 2016.*

- MC Kharar has intimated that they will provide remaining 6 waste deposition centre by 31.12.2022.
- MC Banur has intimated that they have provided 1 waste deposition centre.
- MC Lalru has intimated that they have provided 5 waste deposition centre and remaining 3 will be done by 31.03.2023.
- MC Zirakpur has intimated that they have provided 3 waste deposition centre.
- MC Naya Gaon has intimated that they have provided 0 waste deposition centre as no dumpsite available with them.

No status report received from MC Mohali, Derabassi, Kurali and GMADA.

**DC decided that the remaining ULBs and GMADA shall submit the information to PPCB by 28.07.2022.**

5. *The Monitoring Committee directed that either adequate number of compost pits by the bulk waste generator may be got provided by the concerned MC or shall make agreement with BWGs for lifting and treatment of wet waste with suitable user charges by 31.08.2022 and necessary agreement for lifting and management of dry waste generated by the bulk waste generators may be made by each MC by 31.08.2022.*

- MC Derabassi has intimated that wet waste management done on site by 2 projects M/s SBP and M/s ATS.
- MC Banur has intimated that 4 no. BWGs identified. 3 of them are doing insitu composting and 1 of them made agreement with MC.
- MC Lalru has intimated that there are big industries under the jurisdiction which have provided composting pits for insitu management.
- MC Zirakpur has intimated that BWG are directed to ensure compliance and the same will be completed by 31.12.2023.

No status report received from MC Mohali, Kharar, Kurali, Nayagaon and GMADA.

**DC decided that the remaining ULBs and GMADA shall submit the information to PPCB by 28.07.2022.**

6. *The Monitoring Committee directed that all the MCs shall ensure that the compost pits provided for management of wet waste may be operated scientifically in proper manner and GMADA may provide adequate number of compost pits for treatment of wet waste by 31.01.2023. It was further directed that proper record, mentioning the quantity of wet waste put into the compost pits, quantity of manure produced from processing of wet waste, quantity of manure sold to the farmer or distributed free of cost among the society or utilized in the parks as manure, may be maintained by all the MCs and GMADA.*

- MC Derabassi has intimated that it has provided 32 no. pits at village Saidpura for wet waste composting.
- MC Banur has intimated that it has provided 22 no. pits for wet waste composting.

No status report received from MC Mohali, Kharar, Kurali, Nayagaon, Lalru, Zirakpur and GMADA.

**DC decided that the remaining ULBs and GMADA shall submit the information to PPCB by 28.07.2022**

7. *The Monitoring Committee directed that adequate number of material recovery facilities shall be provided by these MCs by 31.08.2022 and MC Naya Gaon shall pursue the private agency engaged by it for management of solid waste to manage dry waste by 31.08.2022.*

- MC Kharar has intimated that they will provide remaining 6 MRF shed by 31.12.2022.
- GMADA has intimated that work of resource management centre will be completed by 31.03.2023 in 4 GMADA developed projects, by 31.12.2022 in GMADA approved colonies and by 31.03.2023 in unregulated colonies.
- MC Derabassi has intimated that it has provided MRF shed at Village Saidpura.
- MC Lalru has intimated that it has provided required no. of 3 MRF site.
- MC Zirakpur has intimated that it has provided required no. of 3 MRF site.
- MC Naya Gaon has intimated that it has no land available with it.

No status report received from MC Mohali, Banur and Kurali.

**DC decided that the remaining ULBs shall submit the information to PPCB by 28.07.2022**

8. *The Monitoring Committee directed that sanitary land fill site may be provided by all the MCs and GMADA by 31.12.2022.*

- MC Derabassi has intimated that they have constructed the SLF site.
- MC Banur has intimated that resolution has been passed in the house during meeting dated 13.05.2022 and work will be started after tendering.
- MC Lalru has intimated that resolution has been passed in the house during meeting dated 09.05.2022 and work will be completed by 31.03.2023.
- MC Zirakpur has intimated that tender floated on 29.10.2021 but single tender received. Re-tender to be open on 10.06.2022.
- MC Naya Gaon has intimated that it has no land available with it.

No status report received from MC Mohali, Kurali, Kharar and GMADA.

**DC decided that the remaining ULBs and GMADA shall submit the information to PPCB by 28.07.2022.**

9. *The Monitoring Committee directed that quantity of legacy waste lying dumped at dumping site may be reassessed by all MCs by 30.06.2022 and 100% legacy waste may be remediated by all the MCs by 31.03.2023 and the by-products namely Bio-soil, RDF, C & D waste and inert waste produced during remediation of legacy waste may be disposed off in an environmental sound manner and proper record in this regard may be mentioned by each MC.*

- MC Kharar has intimated that out of old 1,21,000 ton legacy waste, 49000 ton remediated. Remaining will be done by 31.03.2023.
- MC Banur has intimated the remediation will be completed by 31.03.2023.

Civil Surgeon has informed that a camp was organized on 08.06.2022 at PHC, Pandwala in which 40 patients were checked of village Kakrali. Earlier, the camp was organized on 26.03.2022 and 18.04.2022 at village Mubarukpur, Meerpur and Bhankarpur.

**DC, SAS Nagar instructed that Civil surgeon, Mohali shall organise camps more frequently and send report to PPCB.**

(H) Environmental Engineer, Punjab Pollution Control Board informed that during last meeting of District Environment Committee, EE, Mining (Water Resources) was requested to ensure that there shall be no case of illegal mining and if any violations found, the matter may be brought into the knowledge of ADC (D) without lapse. The stone crushers shall be visited as per the schedule fixed. However, no report has been received from Mining Department.

(I ). Environmental Engineer, Punjab Pollution Control Board informed that Smt. Suniana has filed petition before Hon'ble NGT in OA No. 490/2022 titled as Suniana Vs State of Punjab and others seeking issuance of appropriate directions to the respondents to ensure supply of potable and clean water to the residents of Zirakpur-Banur-Rajpura belt and to draw comprehensive plan to find out the root causes of contamination of water and suggest remedial measures. The applicant has averred that due to supply of contaminated water, the residents of Zirakpur-Banur-Rajpura belt are suffering from various diseases like cholera, jaundice, typhoid, vomiting, abdominal pain, diarrhea, dehydration and skin-borne diseases. In support of the application, the applicant has placed on record copies of the newspaper reports. Hon'ble NGT vide order dated 08.07.2022 has passed directions as under:

*"We constitute a Joint Committee comprising of representative of State PCB; Principal Secretary, Department of Health, Government of Punjab; Punjab Water Supply and Sewerage Board and Deputy Commissioners, Patiala and Mohali respectively. The Punjab PCB, will be the Nodal agency for coordination and compliance. Factual and action taken report may be furnished within two months by e-mail at judicial-ngt@gov.in preferably in the form of searchable PDF/OCR Support PDF and not in the form of Image PDF. 4. The Joint Committee may meet within four weeks, undertake field visits, look into the allegations made in the application, verify the factual position, draw samples of drinking water supplied to the residents of the localities involved and take remedial action for ensuring supply of clean and safe drinking water to the residents of the concerned localities on sustained basis by following due process of law. The matter is listed for hearing on 10.10.2022."*

**DC, SAS Nagar directed that MC, Zirakpur and MC Banur shall carry out ground water sampling within 7 days and submit report to PPCB.**
