**Subject:** Proceedings of the public hearing conducted on 12.02.2024 in connection with application filed by Executive Engineer-cum-District Mining Officer, SBS Nagar for obtaining environmental clearance under EIA notification dated 14.09.2006 for mining of minor minerals in the revenue estate of Village ADB Rail, Tehsil Balachaur, District SBS Nagar.

It is intimated that the subject cited project proponent has applied to SEIAA, Punjab for obtaining environmental clearance for mining of minor minerals @ 2,00,161 TPA in an area of 12.60 hectares situated in the revenue estate of Village ADB Rail, Tehsil Balachaur, District SBS Nagar. The project is covered under Ministry of Environment Forest & Climate Change (MoEF&CC), Govt. of India, notification no. S.O. 1533 (E) dated 14.09.2006 and thus is required to obtain environmental clearance from SEIAA, Punjab. The 'Terms of Reference' for preparing draft EIA study report for the said project have been prescribed by the SEIAA, Punjab vide No. SIA/PB/MIN/450446/2023 dated 28.11.2023. Accordingly, the project proponent had submitted draft rapid EIA study report alongwith summary report of the same to the Punjab Pollution Control Board and requested for conduct of the public hearing for the proposed project.

In compliance to the provisions laid down in the EIA notification dated 14.9.2006, the date of public hearing for the project was fixed by the Board as 12.02.2024 at site ADB Rail-3, Village ADB Rail Barmad, Near ITI, Rupnagar and the public notice of 30 days in this regard was issued in two daily newspapers on 11.01.2024 namely 'Hindustan Times' and 'Rozana Spokesman' for getting responses from public and intimating time, date & venue of the public hearing. A copy of the said notice is enclosed herewith as Annexure-I. The public announcements and banners were displayed in the vicinity/nearby villages by the Board to give the wide publicity of the public hearing. Thereafter, public hearing for the said project was conducted on 12.02.2024. The public hearing process was supervised & presided
