Subject: Proceedings of the public hearing conducted on 15.06.2023 in connection with application filed by M/s Neelkanth Multimetals, for obtaining environmental clearance under EIA notification, 2006 for the proposed expansion in the existing premises located in the revenue estate of Vill. Majri Mishri, Backside Focal Point, Mandi Gobindgarh, Tehsil Amloh, District Fatehgarh Sahib.

It is intimated that the subject cited industry is an existing unit located in an area of 9.183 acres (5.258 acres area meant for industrial purpose and 3.925 acres reserved for green area) in the revenue estate of Vill. Majri Mishri, Backside Focal Point, Mandi Gobindgarh, Tehsil Amloh, District Fatehgarh Sahib and is engaged in the manufacturing of Steel ingots/billets, angles, channels, flats, TMT Bars, Rounds, Patra/H.R. coil @ 82 TPD (28,700 TPA) by installing an induction furnace of 7 TPH capacity, 1 No. Concast machine and a Rolling Mill. Now, the industry has proposed to increase its manufacturing capacity of Steel ingots/billets, angles, channels, flats, TMT Bars, Rounds, Patra/H.R. coil from 28,700 TPA to 1,68,000 TPA by replacing existing induction furnace of 7 TPH with 30 TPH capacity, by adding 1 No. Rolling Mill in addition to the existing Rolling Mill (Total 2 No. Rolling Mills) and by adding one No. concast machine (Total 2 No. Concast machines), in the existing premises. The project is covered under the EIA notification No. S.O. 1533 (E) dated 14.9.2006 issued by Ministry of Environment, Forest & Climate Change, (MoEF&CC), Govt. of India, New Delhi and thus, the industry is required to obtain Environmental Clearance from State Environment Impact Assessment Authority (SEIAA), Punjab. As a part of the procedure for seeking environmental clearance, as notified by MoEF&CC, the project proponent has prepared draft EIA study report of the proposed project based on the Terms of Reference issued by the SEIAA, Punjab, vide proposal No. SIA/PB/IND1/420746/2023 dated 10.04.2023. The industry had submitted draft EIA study report and other required documents to the Board and had requested for conduct of public hearing of this project.

In compliance to the provisions of the EIA notification dated 14.9.2006 & Office Memorandum dated 14.09.2020, the date of public hearing was fixed as 15.06.2023. Public notices were published in two daily newspapers namely 'The Tribune' & 'Rozana Spokesman' on 13.05.2023 for getting responses from public and intimating date, time & venue of the public hearing. The copies of the said notices are enclosed herewith as Annexure-I. The public announcements and banners were displayed in the vicinity / nearby villages to give the wide publicity of the public hearing by the Board. Thereafter, public hearing for the said project was conducted on 15.06.2023. The public hearing process was supervised & presided over by Sub Divisional Magistrate, Khamano, District Fatehgarh Sahib in the presence of Asstt. Environmental Engineer, PPCB Regional Office, Fatehgarh Sahib. The public hearing was attended by 123 persons and entire process of the said hearing was videographed. A copy of the attendance containing the details of persons, who attended the said hearing along with copy of the (Pendrive) containing video recording, is enclosed herewith as Annexure-II & III, respectively. The site of the industry was visited by the Officers of the Board on 15.06.2023 and the comments regarding construction status, adequacy of pollution control proposal and suitability of site has been received from Senior Environmental Engineer, Zonal Office-2, Patiala vide letter No. 3771 dated 12.10.2023 (Annexure-IV). The gist of the comments as received from the Zonal Office-2, Patiala is as under:-

### Construction status

PUNJAB

No construction work of the proposed project has been started at site.

### Suitability of site

The project is an existing unit and falls in industrial zone as per the notified Master Plan of Mandi Gobindgarh uploaded online in the website of PUDA and as mentioned in the ToR issued by SEIAA, Punjab. Hence, the site is suitable for the installation of the proposed unit.

# Adequacy of pollution control proposals

For discharge of emissions from induction furnaces of capacity 30 TPH, the industry has proposed to install pulse jet bag filter with online technology. As per the current practice, the proposed arrangements for tapping of primary emissions are adequate in principle. But the industry is required to make adequate arrangements for control/tapping secondary emissions generated from the furnaces of CCM as well. Further, for domestic wastewater, STP of 10 KLD capacity is to be installed which is adequate.

The industry has submitted green area map at Regional Office, Fatehgarh Sahib as per the same, green area @ 132016.50 sq. ft in the premises (i.e. 33% of total area of the project i.e. 400050 sqm. The green area proposed by the industry is adequate.

The proceedings of the public hearing reflecting the views & concerns expressed during the public hearing, duly signed by the Sub Divisional Magistrate, Khamano, District Fatehgarh Sahib and Asstt. Environmental Engineer, PPCB, Regional Office, Fatehgarh Sahib, is enclosed herewith as **Annexure-V.** In addition to above, it is requested that the comments of the Board w.r.t construction status, adequacy of pollution control proposal and suitability of site may be considered while deciding application of the project proponent, seeking Environmental Clearance under EIA notification dated 14.09.2006.
