Subject: Proceedings of the public hearing conducted on 09.01.2024 in connection with application filed by Executive Engineer-cum-District Mining Officer, Ludhiana for obtaining environmental clearance under EIA notification dated 14.09.2006 for mining of minor minerals in the revenue estate of Village Sujatwal-Chuharwal and Jamalpur Leli-Kassabad, Tehsil Ludhiana (East), District Ludhiana.

It is intimated that the subject cited project proponent has applied to SEIAA, Punjab for obtaining environmental clearance for mining of minor minerals @ 2,56,435 TPA in an area of 16.03 hectares situated in the revenue estate of Village Sujatwal, Chuharwal, Tehsil Ludhiana (East), District Ludhiana and mining of minor minerals @ 3,69,590 TPA in an area of 22.56 hectares situated in the revenue estate of Jamalpur Leli-Kassabad, Tehsil Ludhiana (East), District Ludhiana. The project is covered under Ministry of Environment Forest & Climate Change (MoEF&CC), Govt. of India, notification no. S.O. 1533 (E) dated 14.09.2006 and thus is required to obtain environmental clearance from SEIAA, Punjab. The 'Terms of Reference' for preparing draft EIA study report for the said project have been prescribed by the SEIAA, Punjab vide No. SEIAA/PB/MIN/2023/TOR/24 dated 21.09.2023 and vide no. SEIAA/PB/MIN/2023/TOR/09 dated 29.08.2023. Accordingly, the project proponent had submitted draft rapid EIA study report alongwith summary report of the same to the Punjab Pollution Control Board and requested for conduct of the public hearing for the proposed project.

In compliance to the provisions laid down in the EIA notification dated 14.9.2006, the date of public hearing for the project was fixed by the Board as 08.01.2024 in Gurudwara Singh Sabha Sahib, Village Jamalpur Leli, Tehsil Ludhiana (East) and the public notice of 30 days in this regard was issued in two daily newspapers namely 'Hindustan Times' and 'Rozana Spokesman' on 06.12.2023 for getting responses from public and intimating time, date & venue of the public hearing.
