Agenda No. 1.1Regarding compliance of Hon'ble NGT order dated 22.09.2022 in O.A. No.606/2018 titled "Compliance of Municipal Solid Waste Management Rules,
2016 & Other Environmental issues"

The Committee noted that in compliance of NGT Order dated 22.09.2022, Rs. 2110 Crore has been ring-fenced vide CS order dated 22.11.2022. Further, Committee under the chairmanship of Principal Secretary, Local Government has been constituted vide order dated 11.11.2022 to regularly assess the progress in bridging the gaps in sewage and solid waste management. Further, PMIDC has submitted the six-monthly progress report to NGT in May, 2023.

Agenda No. 1.2 Review of monitoring of Water Quality of Rivers

1. Status of Sewage Generation & Treatment

The Committee was apprised about the infrastructure available for sewage treatment, gap in sewage treatment and infrastructure proposed to be set up to address the gap for the management of domestic sewage in the State.

2. Status of water quality of polluted river stretches

- (i) The Committee was appraised that as per CPCB Report 2022, 2 new polluted river stretches (Sirsa-along Baddi and Swan-along Santoshgarh) have been added and 1 river stretch (Beas-along Mukerian) have been removed from existing list of 4 polluted stretches as per 2018 CPCB report. Further, PPCB informed that the 2 polluted stretches of River Sirsa and Swan does not fall in Punjab.
- (ii) The Committee directed MS PPCB, to check the data and take up the matter with CPCB regarding removal of these 2 stretches from the polluted river stretches list of Punjab.

3. Water quality analysis by Real Time Water Quality Monitoring Stations (RTWQMS)

The Committee noted the progress.

- 4. Development of Low-Cost Sensor to monitor various parameters by IIT Ropar.
 - (i) PPCB informed that 5 sites have been identified for installing the nodes and the permission has been obtained from Dept. of Water Resources.

The node at Sutlej, near Ropar has been installed and will be functional from 20.06.2023 and the remaining notes are likely to be installed before 23.08.2023.

(ii) The Committee directed PPCB that all the nodes shall be made functional by 23.08.2023.

5. Setting up of Integrated Dashboard for online monitoring

- (i) The Committee in the last meeting directed PPCB to re-initiate the tendering process for setting-up of integrated dashboard for online monitoring.
- (ii) The Committee directed PPCB to present the updated status regarding the action taken in the matter in the next meeting of the Committee.

Agenda No. 1.3 Review of Monitoring of functioning of STPs in the catchment area

1. Status of STP Monitoring

- (i) The Committee directed the CEE (Water), PPCB to write a letter to all the Regional Officers of PPCB directing that the sampling of STPs be carried out jointly with the District Administration officials (preferably concerned ADCs looking after the District Environment Plans) to reduce the extent of non-compliance of STPs especially failing due to F.Coli.
- (ii) It was further directed that regular checking be done in the next two months, and updated status be provided in the next meeting.
- (iii) The Committee directed DLG to ensure that adequate chlorination is done and no STP should fail because of F-Coli.

2. Action taken by PPCB against non-compliant STPs

The Committee directed PPCB to provide the updated status regarding the actions taken against non-compliant STPs.

Agenda No. 1.4 Review of monitoring of functioning of CETPs & ETPs in the catchment area of the rivers

1. Status of CETP monitoring

- (i) PPCB informed that EC amounting to Rs 1.35 Crores has been imposed on the SPV of 15 MLD CETP.
- (ii) The Committee directed PPCB to initiate legal action against the SPV of 15 MLD CETP in case the SPV fail to achieve the permissible discharge standards and zero liquid discharge within reasonable time frame.
- (iii) The Committee also directed PPCB to give reasonable timeframe to the

SPVs of 40 MLD and 50 MLD CETPs to achieve the permissible discharge standards failing which action shall be initiated as per the provisions of Water Act, 1974.

- (iv) The Committee also directed DC, Ludhiana to draw pool of officers from PPCB, DLG, MC, Ludhiana and other relevant departments to monitor the discharge of CETPs on regular basis.
- (v) The Committee directed ADCs to ensure conducting monthly meetings of District Environment Committee under the chairmanship of respective DCs.

2. Status of ETP Monitoring

- (i) The Committee noted the progress.

The reasons for slow progress is due to disparity of rates in different cities and higher rates of PNG caused by Russia Ukraine war. It was further informed that the timeline for conversion of industries at Mandi Gobindgarh/ Khanna has been extended upto 31.12.23 whereas, the timeline for Amritsar has been relaxed till the issue of Russia Ukraine war is resolved.
