M/s Pritika Industries Ltd., Village Fatehgarh, Sub Tehsil Morinda, Tehsil Chamkaur Sahib, District Ropar	<p>The case was considered by the SCA-cum-SAC in its 94<sup>th</sup> meeting held on 28.07.2016, wherein the SCA-cum-SAC observed that the case stands recommended by all the member departments except DOA.</p> <p>The representative of DOA informed that the matter is pending with Deputy Commissioner, Ropar to the effect as to whether the site falls in Morinda block (notified area) or in the Ropar Block (Safe zone).</p> <p>The SCA-cum-SAC further observed that the matter is still pending with Deputy Commissioner, Ropar and no progress has been made by the Department of Agriculture after 93<sup>rd</sup> meeting of SCA-cum-SAC, which was held on 06.06.2016. The SCA-cum-SAC has taken very serious view of the same.</p> <p>After discussions, it was decided that Director Agriculture, Punjab will get the D.O. letter issued from the Chairperson SCA-cum-SAC to Financial Commissioner (D) with copy to Deputy Commissioner, Ropar mentioning complete detail of the case/delay occurred in disposing off the case and for getting the requisite information from the Deputy Commissioner, Ropar.</p> <p>It was further decided that DOA will send the final recommendations in the matter within 15 days, positively and the case be put up in the next meeting of SCA-cum-SAC.</p>

M/s Max Speciality Films Ltd., Village Railmajra, Tehsil Balachaur, District Nawanshahr	<p>The case was considered by the SCA-cum-SAC in its 94<sup>th</sup> meeting held on 28.07.2016, wherein the SCA-cum-SAC observed that the The case stands recommended by all the member departments except PCCF.</p> <ul style="list-style-type: none"> <li>PCCF vide letter No. 7679 dated 26.07.2016 informed that the DFO, Nawanshahr has written the user agency vide letter No. 2538 dated 19.07.2016 to deposit Rs.9,22,965/- as Greening Punjab Mission Fund and Rs.1000/- as application processing fee, as per the policy of the State Govt. PCCF further informed that after</li> </ul>

the deposit of aforesaid amount by the industry, the case of the industry will be sent to Govt. of Punjab for according permission for sending the case to Govt. of India.

- During the meeting, representative of PCCF informed that the industry has deposited the above mentioned amount and the case of the industry will be sent to the Govt. of Punjab, shortly for according necessary permission.

After discussions, the representative of PCCF was directed to expedite the matter and to send the final recommendations in the matter within a week, positively and the case be put up in the next meeting of SCA-cum-SAC.

3. M/s Symmetrix Biotech Pvt. Ltd., Plot No. 16, Phase-IX, Industrial Area, Mohali
- The case was considered by the SCA-cum-SAC in its 94<sup>th</sup> meeting held on 28.07.2016, wherein the SCA-cum-SAC observed that the case stands recommended by all the member departments except CFO. The industry vide its letter dated 26.7.2016 has requested to grant one month time to submit the reply of the observations raised by Chief Fire Officer as the industry is in contact with highly specialized & reputed firm of Consulting Engineers and is preparing a technical report regarding observations of CFO. The request of the industry has been received directly to SCA-cum-SAC as well as through PBIP.

After discussions, it was decided to accept the request of the industry and to ask the industry to submit proper reply to the observations raised by Chief Fire Officer to PBIP as well as to SCA-cum-SAC, within one month positively. The case be put up in the next meeting of SCA-cum-SAC with the conclusive recommendations of Chief Fire Officer through PBIP.

After discussions, the representative of DOA was directed to expedite the matter and submit its final report at the earliest. The case be deferred and be put up in the next meeting of SCA-cum-SAC.
2.	M/s Singla Solvent, Village Maur Nabha, Pakho Kanchian Road,	The case was considered by the SCA-cum-SAC in its 94 <sup>th</sup> meeting held on 28.07.2016, wherein the SCA-cum-SAC observed that the case stands recommended by all

Tehsil Tapa, District Barnala the member departments except PCCF. PCCF vide letter no. 7672 dated 26.07.2016 informed that the proposal of the industry for using forest land as approach to the industrial premises has been sent to the Govt. of Punjab vide U.O. no. 501 dated 13.07.2016 for according approval.

After discussions, representative of PCCF was directed to expedite the matter for sending the proposal to the Govt. of India, Ministry of Environment, Forests & Climate Change for according in-principle approval and to send the final recommendations in the matter within a week, positively. It was further decided to defer the case and be put up in the next meeting of SCA-cum-SAC alongwith the final recommendations of PCCF.

3. M/s Bindi Industries, Village Dangora, District Ludhiana The case was considered by the SCA-cum-SAC in its 94<sup>th</sup> meeting held on 28.07.2016, wherein the SCA-cum-SAC after discussions, the representative of CTP, Punjab was directed to give the clear cut recommendations in the matter, within 15 days for deciding the case. The case be put up in the next meeting of SCA-cum-SAC.
  
4. M/s Kunal Enterprises, Dhogri Road, V.P.O., Dhogri, District Jalandhar The case was considered by the SCA-cum-SAC in its 94<sup>th</sup> meeting held on 28.07.2016, wherein the SCA-cum-SAC observed that □ DOF, IMD & DHS have recommended for grant of site clearance to the industry.
  - PPCB & PCCF have also recommended for grant of site clearance to the industry vide letter No. 6507 dated 27.07.2016 and No. 7716 dated 26.07.2016, respectively.
  - Comments from DOI & CFO are awaited.
  - CTP, Punjab vide letter No. 3639 CTP (Pb)/SS-200 dated 27.07.2016 has informed that:
    - The site of the industry falls in the revenue estate of Village Dhogri, Hadbast No. 164, District Jalandhar on 22 ft. wide Jalandhar-Alawalpur Road. The site falls in Industrial Zone as per the notified Master Plan of Jalandhar.
    - As per the report of DTP, Jalandhar, the land of the site is the property of Wakf Board and the land area measuring 1211 sqm was given on lease by Wakf Board vide Lease Order No. 24/lease-Urban/F.No.2575/06 /9260 dated 28.03.2007 to Sh. Parminder Singh S/o Sh. Balbir Singh for 11 months for godown and making boundary wall. The period of the lease of the land has been expired.
    - The lease period of the land required for conversion of land use should be minimum 15 years. The land was given on lease for godown and making

boundary wall only, whereas as per the application, the industry intends to establish the unit for manufacturing of carbon black and wire.

- Earlier, the applicant has applied to the DTP, Jalandhar for seeking clarification regarding classification of the area of the site. As per the revenue documents submitted by the applicant at that time, the owner of the site was shown Sh. Anup Kumar Ratti S/o Sh. Davinder Nath Ratti, but as per the documents submitted with the application under consideration, the owner of the site is Wakf Board, which are not tallying with each other. Therefore, the clarification regarding ownership of the site is required.

□ DOA vide Endst. No. 1658/JDA (HG) dated 27.07.2016 informed that the unit is lying sealed on the main gate due to which no verification could be done and it could not be ascertained as to why & due to which reasons, the unit is lying sealed.

To this observation of DOA, Chairman, Punjab Pollution Control Board informed that the unit has already been visited by the other departments, therefore, DOA should also visit the unit.

After discussions, following decisions were taken:

(i) Observations of CTP, be conveyed to the industry for compliance and the industry be directed to submit the compliance report of the same to CTP, Punjab directly under intimation to the SCA-cum-SAC.

(ii) The representatives of DOI & CFO were directed to expedite the matter and to send the final recommendations in the matter within a week, positively.

(iii) DOA was also directed to send the final comments within 10 days, positively.

(iv) Case be deferred till the industry submits the reply of the observations of CTP, Punjab.

5. M/s Shree Mahavir Agricultural Industries, Village Kutbewal, G.T. Road, Goraya, District Jalandhar

The case was considered by the SCA-cum-SAC in its 94<sup>th</sup> meeting held on 28.07.2016, wherein the SCA-cum-SAC observed that The SCA-cum-SAC observed as under:

- □ DOF, IMD, DHS & CFO have recommended for grant of site clearance to the industry.
- □ DOI & PCCF have also recommended for grant of site clearance to the industry vide letter No. 10879-A dated 27.07.2016 and No. 7719 dated

26.07.2016, respectively.

- Comments from DOA are awaited.
- PPCB, vide letter No. 6506 dated 27.07.2016 has informed that although the industry has submitted the letter from Naib Tehsildar to the effect that the site of the industry falls outside the lal lakir of Village Kutbewal but the distance has not been mentioned in the certificate. Punjab Pollution Control Board has recommended the case for grant of site clearance after getting report from Revenue Authority regarding distance of lal lakir of Village and considering the land use pattern from District Town Planner.
- CTP, Punjab vide letter No. 3636 CTP (Pb)/SJ-200 dated 27.07.2016 informed that the site of the industry falls in the revenue estate of Village Kutbewal, Tehsil Phillaur, District Jalandhar. Further, it has been informed that as per report of Naib Tehsildar, Sub Tehsil Guraya, the area of the site falls in Nagar Panchayat Guraya. CTP, Punjab has also informed that the competency for change of land use, layout plan & approval of building plans lies with the Local Govt. where the area falls in jurisdiction of Local Govt. Department. The CTP, Punjab further informed that the report in this regard may be obtained from Local Govt. Department.

The SCA-cum-SAC was apprised that as per the letter No. 691 DTP(J)/SSV-1 dated 12.05.2016 issued by the DTP, Jalandhar to the industry, (submitted by the industry with the application), the site falls in khasra No. 423 & 425 in the revenue estate of Village Kutbewal (Hadbast No. 219), Tehsil Guraya and the site does not fall in any Municipal Council. It has been further mentioned in the letter that this site falls in Notified Local Planning Area of Guraya and the Master Plan of Guraya is under preparation.

After discussions, following decisions were taken:

(i) Observations of Punjab Pollution Control Board be conveyed to the industry for compliance and the industry be directed to submit the compliance report of the same to PPCB directly under intimation to the SCA-cum-SAC and PPCB shall send the fresh recommendations.

(ii) Copy of letter No. 691 DTP(J)/SSV-1 dated 12.05.2016 issued by the DTP, Jalandhar to the industry, (submitted by the industry with the application) be sent to CTP, Punjab for sending fresh comments/clear cut recommendations in the matter, within 7 days, positively.

(iii) Representative of DOA was directed to send the final comments/recommendations in the matter, within 10 days, positively.

(iv) Case be deferred till the industry submits the reply of the observations of PPCB.

6. M/s G.K. (India), Village Dangora, District Ludhiana  
The case of the industry has been received on 19.07.2016 and the same was sent to the Member departments on 19.07.2016 for comments and the same will be put up before SCA-cum-SAC in its next meeting.
