**Subject:** Proceedings of the public hearing conducted on 11.07.2024 in connection with application filed by Executive Engineer-cum-District Mining Officer, SBS Nagar for obtaining environmental clearance under EIA notification dated 14.09.2006 for mining of minor minerals in the revenue estate of Village Talwandi Sibhu, Laalewal & Khoja, Tehsil Nawanshahar, District SBS Nagar.

It is intimated that the subject cited project proponent has applied to SEIAA, Punjab for obtaining environmental clearance for mining of minor minerals @ 6,26,670 TPA in an area of 45.65 hectares situated in the revenue estate of Village Talwandi Sibhu, Laalewal & Khoja, Tehsil Nawanshahar, District SBS Nagar. The project is covered under Ministry of Environment Forest & Climate Change (MoEF&CC), Govt. of India, notification no. S.O. 1533 (E) dated 14.09.2006 and thus is required to obtain environmental clearance from SEIAA, Punjab. The 'Terms of Reference' for preparing draft EIA study report for the said project have been prescribed by the SEIAA, Punjab vide letter dated 14.12.2024. Accordingly, the project proponent had submitted draft rapid EIA study report alongwith summary report of the same to the Punjab Pollution Control Board and requested for conduct of the public hearing for the proposed project.

In compliance to the provisions laid down in the EIA notification dated 14.9.2006, the date of public hearing for the project was fixed by the Board as 11.07.2024 in Govt. Primary School, Village Talwandi Sibhu, Tehsil Nawanshahar District SBS Nagar and the public notice of 30 days in this regard was issued in two daily newspapers on 09.06.2024 namely 'Indian Express' and 'Punjabi Tribune' and corrigendum published on 12.06.2024 in 'The Indian Express' for getting responses from public and intimating time, date & venue of the public hearing. A copy of the said notices is enclosed herewith as Annexure-I. The public announcements and banners were displayed in the vicinity/nearby villages by the Board to give the wide publicity of the public hearing. Thereafter, public hearing for the said project was conducted on 11.07.2024. The public hearing process was supervised & presided over
