Subject: Proceedings of the public hearing conducted on 27.08.2024 in connection with application filed by M/s Saidpura Envirotech Pvt Ltd., for conduct of public hearing for obtaining environmental clearance under EIA notification dated 14.09.2006, for expansion of existing boiler capacity from 10 TPH to 22 TPH in the revenue estate of Village Saidpura, Dera Bassi, District SAS Nagar.

It is intimated that M/s Saidpura Envirotech Pvt Ltd., has proposed to develop Common Effluent Treatment Plant (CETP) of 5 MLD (2 MLD in Phase-I and 3 MLD in Phase-II) capacity in an area of 7 acres in the revenue estate of Village Saidpura, Tehsil Dera Bassi, District -SAS Nagar, Mohali and has obtained environmental clearance for the project from Ministry of Environment, Forest & Climate Change (MoEF&CC) vide letter no.F.No.10-66/2013-IA.III dated 23.03.2015. The project is under construction and is in advance stage of completion. Now, the project proponent has proposed to expand its unit by increasing the capacity of boiler from 10 TPH to 22 TPH. The project is covered under category A of the EIA notification No. S.O. 1533 (E) dated 14.9.2006 issued by Ministry of Environment, Forest & Climate Change, (MoEF&CC), Govt. of India, New Delhi and thus, the project proponent is required to obtain Environmental Clearance from MoEF&CC. As a part of the procedure for seeking environmental clearance, as notified by MoEF&CC, the project proponent has prepared draft EIA study report of the proposed project based on the Terms of Reference issued by the MoEF&CC, New Delhi, vide No. 21-47/2023-IA.III dated 29.01.2024. The project proponent had submitted draft EIA study report to the Board and had requested for conduct of public hearing of this project.

In compliance to the provisions of the EIA notification dated 14.09.2006 & Office Memorandum dated 14.09.2020, the Board fixed the date of public hearing as 27.08.2024. Public notices were published in two daily newspapers namely 'Hindustan Times' & 'Rozana Spokesman' on 24.07.2024 for getting responses from public and intimating date, time & venue of public hearing. The copies of the said notices are enclosed herewith as Annexure-I. The public announcements and banners were displayed in the vicinity / nearby

villages to give wide publicity of the public hearing, by the Board. Thereafter, public hearing for the said project was conducted on 27.08.2024. The public hearing process was supervised and presided over by the Sub Divisional Magistrate, Dera Bassi, District Mohali in the presence of Environmental Engineer & Asstt. Environmental Engineer, PPCB Regional Office, Mohali. The public hearing was attended by 73 persons and the entire process of the said hearing was videographed. A copy of the attendance containing the details of persons, who attended the said hearing along with copy of the Pen drive containing video recording & album of photos, is enclosed herewith as **Annexure-II & III**, respectively.

The proceedings of the public hearing reflecting the views & concerns expressed during the public hearing, duly signed by the Sub Divisional Magistrate, Dera Bassi, District Mohali in the presence of Environmental Engineer & Asstt. Environmental Engineer, PPCB Regional Office, Mohali, are attached herewith as **Annexure-IV** for taking further necessary action at the end of the Ministry, please.
