Proceedings of the public hearing conducted on 30.11.2023 in connection with application filed by M/s Shree Ganesh Alloys, for obtaining environmental clearance under EIA notification, 2006 for the proposed expansion in the existing premises located in the revenue estate of Vill. Tooran, Tehsil Amloh, Mandi Gobindgarh, Distt. Fatehgarh Sahib.

It is intimated that the subject cited industry is an existing unit located in an area of 3.36 acres located in the revenue estate of Village Tooran, Tehsil Amloh, Mandi Gobindgarh, Distt. Fatehgarh Sahib and is engaged in the manufacturing of Ingots @ 84 TPD (29,400 TPA) -by installing an induction furnace of 6 Ton/heat capacity. Now, the industry has proposed to manufacture Billets/ingots or Rolled products (TMT Bars/Flats/Patra/Angles/ Structure/ Channels etc. @ 380 TPD (1,33,000 TPA) (Total after expansion) in its existing premises by replacing existing induction furnace of 6 ton/heat capacity with 10 Ton/heat capacity and installation of another 1 no. induction furnaces of 15 Ton/heat alongwith 1 no. Rolling Mill. The project is covered under the EIA notification No. S.O. 1533 (E) dated 14.9.2006 issued by Ministry of Environment, Forest & Climate Change, (MoEF&CC), Govt. of India, New Delhi and thus, the industry is required to obtain Environmental Clearance from State Environment Impact Assessment Authority (SEIAA), Punjab. As a part of the procedure for seeking environmental clearance, as notified by MoEF&CC, the project proponent has prepared draft EIA study report of the proposed project based on the Terms of Reference issued by the SEIAA, Punjab, vide No. SEIAA/MS/2022/326 dated 28.07.2022. The industry had submitted draft EIA study report and other required documents to the Board and had requested for conduct of public hearing of this project.

In compliance to the provisions of the EIA notification dated 14.9.2006 &Office Memorandum dated 14.09.2020, the date of public hearing was fixed as 30.11.2023. Public notices were published in two daily newspapers namely 'Hindustan Times' & 'Rozana Spokesman' on 27.10.2023 for getting responses from public and intimating date.

time & venue of the public hearing. The copies of the said notices are enclosed herewith as Annexure-I. The public announcements and banners were displayed in the vicinity / nearby villages to give the wide publicity of the public hearing by the Board. Thereafter, public hearing for the said project was conducted on 30.11.2023. The public hearing process was supervised & presided over by the Additional Deputy Commissioner (G), Fatehgarh Sahib in the presence of Environmental Engineer & Asstt. Environmental Engineer, PPCB Regional Office, Fatehgarh Sahib. The public hearing was attended by 32 persons and entire process of the said hearing was videographed. A copy of the attendance containing the details of persons, who attended the said hearing along with copy of the (Pendrive) containing video recording, is enclosed herewith as Annexure-II & III, respectively. The site of the industry was visited by the Officers of the Board on 30.11.2023 and the comments regarding construction status, adequacy of pollution control proposal and suitability of site has been received from Senior Environmental Engineer, Zonal Office-2, Patiala vide letter No. 4582 dated 29.12.2023 (Annexure-IV). The gist of the comments as received from the Zonal Office-2, Patiala is as under:-

## **Construction status**

PUNJAB

No construction work of the proposed project has been started at site.

#### Suitability of site

The site of the industry (Tooran) falls in Industrial Zone as per the notified Master Plan of Mandi Gobindgarh uploaded online in the website of PUDA and as mentioned in the ToR issued by SEIAA, Punjab. Hence, the site is suitable for the installation of the proposed unit.

### Adequacy of pollution control proposals

For discharge of emissions from induction furnace of capacity 10 TPH & 15 TPH, the industry has proposed to install side suction hood with pulse jet bag filter with offline technology. As per the current practice, the proposed arrangements for tapping of primary emissions are adequate in principle. But the industry is required to make adequate arrangements for control/tapping secondary emissions generated from the furnaces & CCM as well. Further for domestic wastewater, STP of 10 KLD capacity is to be installed which is adequate.

As per the report of Zonal Office-2, Patiala, the industry has submitted proposal for developing green area @ 13410.08 sqm in premises (i.e. 18.01% of total area of the project i.e. 2416.35 sqm). In order to meet requirement 33% green area, additional land has been acquired outside of project premises. It is observed that green area proposed by the industry is adequate. ...Contd. P-3
