Proceedings of the public hearing conducted on 31.10.2023 in connection with application filed by M/s T.C.G. Alloys, for obtaining environmental clearance under EIA notification, 2006 for the proposed expansion in the existing premises located in the revenue estate of Vill. Ajnali, Bakcside Baddi Bhawani, Mandi Gobindgarh, District Fatehgarh Sahib.

It is intimated that the subject cited industry is an existing unit located in an area of 10,222 sqm located at Village Ajnali, Bakcside Baddi Bhawani, Mandi Gobindgarh, District Fatehgarh Sahib and is engaged in the manufacturing of Billets/ingots @ 72 TPD by installing an induction furnace of 6 Ton/heat capacity.

Now, the industry has proposed to increase the production capacity of Billets/ingots or Rolled products (Bars, flats & Rounds) from 72 TPD to 150 TPD (Total after expansion) in its existing premises by replacing existing induction furnace of 6 ton/heat capacity to 10 Ton/heat capacity alongwith Rolling Mill. The project is covered under the EIA notification No. S.O. 1533 (E) dated 14.9.2006 issued by Ministry of Environment, Forest & Climate Change, (MoEF&CC). Govt. of India, New Delhi and thus, the industry is required to obtain Environmental Clearance from State Environment Impact Assessment Authority (SEIAA), Punjab. As a part of the procedure for seeking environmental clearance, as notified by MoEF&CC, the project proponent has prepared draft EIA study report of the proposed project based on the Terms of Reference issued by the SEIAA, Punjab, vide No. SEIAA/MS/2023/975 dated 08.08.2023. The industry had submitted draft EIA study report and other required documents to the Board and had requested for conduct of public hearing of this project.

Office Memorandum dated 14.09.2020, the date of public hearing was fixed as 31.10.2023. Public notices were published in two daily newspapers namely 'Hindustan Times' & 'Rozana Spokesman' on 27.09.2023 for getting responses from public and intimating date, ...Contd. P-2

Annexure-I. The public announcements and banners were displayed in the vicinity / nearby villages to give the wide publicity of the public hearing by the Board. Thereafter, public hearing for the said project was conducted on 31.10.2023. The public hearing process was supervised & presided over by the Additional Deputy Commissioner, Fatehgarh Sahib in the presence of Environmental Engineer (Mega), PPCB, Head Office, Patiala & Asstt. Environmental Engineer, PPCB Regional Office, Fatehgarh Sahib. The public hearing was attended by 61 persons and entire process of the said hearing was videographed. A copy of the attendance containing the details of persons, who attended the said hearing along with copy of the (Pendrive) containing video recording, is enclosed herewith as Annexure-II & III, respectively. The site of the industry was visited by the Officers of the Board on 31.10.2023 and the comments regarding construction status, adequacy of pollution control proposal and suitability of site has been received from Senior Environmental Engineer, Zonal Office-2, Patiala vide letter No. 4272 dated 29.11.2023 (Annexure-IV). The gist of the comments as received from the Zonal Office-2, Patiala is as under:-

Construction status

No construction work of the proposed project has been started at site.

Suitability of site

The site of the industry (Ajnali) falls in Industrial Zone as per the notified Master Plan of Mandi Gobindarh uploaded online on the website of PUDA and as mentioned in the ToR issued by SEIAA, Punjab. Hence, the site is suitable for the installation of the proposed unit.

Adequacy of pollution control proposals

For discharge of emissions from induction furnace of capacity 10 Ton/heat capacity, the industry has proposed to install side suction hood followed by pulse jet bag filter with offline technology. As per the current practice, the proposed arrangements for tapping of primary emissions are adequate in principle, but the industry is required to make adequate arrangements for control/tapping secondary emissions generated from the furnaces & CCM as well. Further, for domestic wastewater, STP of 5 KLD capacity is to be installed which is adequate.

The industry has submitted proposal for developing green area @ 10222.43 sqm in the premises (i.e. 18% of total area of the project i.e. 1848.75 sqm). In order to meet requirement of 33% green area, additional land has been acquired. It is observed that green area proposed by the industry is adequate.

The proceedings of the public hearing reflecting the views & concerns expressed during the public hearing, duly signed by the Additional Deputy Commissioner, Fatehgarh Sahib in the presence of Environmental Engineer (Mega), PPCB, Head Office Patiala & Asstt. Environmental Engineer, PPCB Regional Office, Fatehgarh Sahib, is enclosed herewith as **Annexure-V**. In addition to above, it is requested that the comments of the Board w.r.t construction status, adequacy of pollution control proposal and suitability of site may be considered while deciding application of the project proponent, seeking Environmental Clearance under EIA notification dated 14.09.2006.
