Subject: Proceedings of the public hearing conducted on 18.06.2024 in connection with application filed by M/s Tee Dee Alloys, for obtaining environmental clearance under EIA notification, 2006 for the proposed expansion in the existing premises located in the revenue estate of Village Wazir Nagar, Ambey Majra Road, Mandi Gobindgarh.

It is intimated that the subject cited industry is an existing unit located in an area of 3.11 acres in the revenue estate of Village Wazir Nagar, Ambey Majra Road, Sirhind, Distt Fatehgarh Sahib and is engaged in the manufacturing of Steel ingots/billets @ 29,400 TPA & TMT Bars, Round, flats, angle and channel @ 28,700 TPA by installing an induction furnace of 7 Ton/heat capacity, 1 No. Rolling Mill, Ladle Refining Furnace (LRF) & CCM. Now, the industry has proposed to increase its manufacturing capacity of Steel ingots/billets from 29,400 TPA to 1,40,000 TPA & TMT Bars, Round, flats, angle and channel from 28,700 to 1,37,000 TPA (Total after expansion) in its existing premises by replacing existing induction furnace of 7 ton/heat capacity with 2 no. induction furnaces of 10 & 15 Ton/heat capacity besides existing 1 No. Rolling Mill, 1 No. Ladle Refining Furnace (LRF) & 1 No. concast machine (CCM). The project is covered under the EIA notification No. S.O. 1533 (E) dated 14.9.2006 issued by Ministry of Environment, Forest & Climate Change, (MoEF&CC), Govt. of India, New Delhi and thus, the industry is required to obtain Environmental Clearance from State Environment Impact Assessment Authority (SEIAA), Punjab. As a part of the procedure for seeking environmental clearance, as notified by MoEF&CC, the project proponent has prepared draft EIA study report of the proposed project based on the Terms of Reference issued by the SEIAA, Punjab, vide No. SEIAA/MS/2023/1222 dated 05.09.2023. The industry had submitted draft EIA study

report and other required documents to the Board and had requested for conduct of public hearing of this project.

In compliance to the provisions of the EIA notification dated 14.9.2006 & Office Memorandum dated 14.09.2020, the date of public hearing was fixed as 18.04.2024. Public notices were published in two daily newspapers namely 'The Tribune' & 'Jagbani' on 16.03.2024 for getting responses from public and intimating date, time & venue of the public hearing. The copies of the said notices are enclosed herewith as **Annexure-I**. Thereafter, the above-mentioned public hearing was postponed to 18.06.2024 due to imposition of Model Code of Conduct w.r.t. General Lok Sabha Elections-2024. The public notice was got published in the same newspapers in which earlier public notice was published i.e. 'The Tribune' & 'Jagbani' on 11.04.2024, copies of the same are attached herewith **Annexure-II**. The public announcements and banners were displayed in the vicinity / nearby villages to give the wide publicity of the public hearing by the Board. Thereafter, public hearing for the said project was conducted on 18.06.2024. The public hearing process was supervised & presided over by the Sub Divisional Magistrate, Fatehgarh Sahib in the presence of Environmental Engineer & Asstt. Environmental Engineer, PPCB Regional Office, Fatehgarh Sahib. The public hearing was attended by 50 persons and entire process of the said hearing was videographed. A copy of the attendance containing the details of persons, who attended the said hearing along with copy of the (Pendrive) containing video recording, is enclosed herewith as **Annexure-III & IV**, respectively.

The proceedings of the public hearing reflecting the views & concerns expressed during the public hearing, duly signed by the Sub Divisional Magistrate, Fatehgarh Sahib in the presence of Environmental Engineer & Asstt. Environmental Engineer, PPCB Regional Office, Fatehgarh Sahib, are enclosed herewith as **Annexure-V** for information & further necessary action at your end.




